1. RELATIONSHIP OF RELEASE AND UPDATE

THE PURPOSE OF THE PRODUCT UPDATE NOTICE IS TO PROVIDE THE USER WITH SPECIFIC INFORMATION NOT AVAILABLE IN THE PRODUCT MANUALS. A PIECE OF INFORMATION MAY BE REPEATED IN MORE THAN ONE UPDATE NOTICE IF THE APPROPRIATE MANUAL IS NOT YET AVAILABLE.

BETWEEN REVISIONS OF THE PRODUCT, PERIODIC UPDATES TO THE PRODUCT MAY BE ISSUED. THE PURPOSE OF AN UPDATE IS TO PROVIDE A LEVEL OF CORRECTIONS TO THE PRODUCT THAT DOES NOT REQUIRE A RELEASE OF THE COMPLETE PRODUCT (WHICH IS WHAT DISTINGUISHES A RELEASE FROM AN UPDATE). AN UPDATE USUALLY CONSISTS OF A PATCH FILE ON MACHINE-READABLE MEDIA AND A PRINTED UPDATE NOTICE. WE RECOMMEND THAT THE UPDATE NOTICE AND ITS SUBSEQUENT UPDATE NOTICES BE FILED AND REFERENCED SO THAT THE CURRENT STATE OF THE PRODUCT CAN BE MAINTAINED.
