## NEWSLETTERS AND BULLETINS

The Weekly Newsletters were first produced because of the need to provide accurate up-to-date information as soon as possible. The monthly Bulletin; because of the time involved in editing and collating of information, preparation of masters and actual printing; could not possibly produce information that was completely up-to-date. Although the content of the Newsletters is consolidated and included in each Bulletin this time lag is still apparent. Users may receive a copy of a Bulletin detailing an error that has been reported as fixed in a Newsletter of a later date. For this reason, in this and future Bulletins, any item extracted from a Newsletter will be identified by number of that Newsletter. In this way users may check on the date of the item in the Bulletin and any subsequent Newsletters that have appeared, in order to be aware of the true state of events.

## CHRISTMAS SHUT DOWN

The Computer Centre will shut down on Christmas Eve and remain closed during the intervening days between Christmas and New Year. No further work will be processed after 11.30 p.m. on Thursday 23 December. However, the Centre will remain open until 1 p.m. on Friday 24 December to allow staff to finalize end-of-year accounting and users to collect any work or card punching. The Centre will re-open at 9 a.m. on Tuesday 4 January 1972.

## EXTENSION OF CONSULTING HOURS

[WN-59,60]

The hours available for programmer consultations have been extended. The new hours are:

Wednesday	10.30 a.m. - 1.00 p.m.

Friday	10.30 a.m. - 1.00 p.m.

While prior appointments for a consultation are not necessary during these hours, preference is given to clients who make appointments in advance. Note that, as previously, requests for consultation must be made through the Administrative Officer, Mr John Jauncey. Similarly, phone enquiries on programming problems must be directed to Mr Jauncey, extension 8471.

The member of staff available for consultation has other responsibilities for the smooth running of the system which will take priority over his consulting functions. These arrangements have been made in part to reduce the number of interruptions to staff members who have a very heavy commitment to the developmental work of the Centre. Consequently, consultation will not be given outside the above hours. Any direct approaches to programmers or requests for consultation outside the advertised times will be refused.

### COMPUTER CENTRE HARDWARE DEVELOPMENT

The Computer Centre is currently engaged in a number of modifications to existing equipment, and is planning development of new hardware.

Nearing completion are modifications to the line printer to provide automatic page counting, and a facility for bursting forms online. The burst facility will be under program control, and will alleviate the onerous task of separating output, as approximately 300 printer files are produced each day.

A hardware character decoder has been designed for the card reader, which will substantially reduce the amount of processor time previously required for software decoding. A common facility for determining the status of the card reader and printer has also been installed to simplify symbiont operation.

Design is proceeding on a general purpose communications interface that will allow devices of various characteristics to be connected to the system. Investigations into methods of improving the performance of the fixed head disks used for swapping are currently being carried out.

A very serious problem of transistor lead failure due to corrosion has been investigated, resulting in the design of adequate filters throughout the system.

### NEW SYSTEMS PROGRAMS

#### (a) New Login, Logout and Decode

[WN-55]

In conjunction with the release of the new version of Batch on 9 September, new versions of Login, Logout, Loader and Decode were implemented. As well as incorporating changes made necessary by the introduction of the new Batch, these programs were changed in order to speed up their operation, and to provide improved error messages.

Two of the changes to Decode need to be mentioned specifically:

- (i) RUN (with no arguments) will not attempt to execute, if there were errors in compilation.
- (ii) LOG PJ =1 (for example) gave an 'ILLEGAL ASSIGNMENT' because of the space before the equals. This has been fixed.

A further change will be made to Logout as soon as possible. If the user's logged out limit is exceeded while logging out in Batch, the user's file directory will be listed once only before any files are deleted. At present, the directory is listed three times.

(b) New Monitor

[WN-59]

A new monitor became operational on Thursday 23 September. The changes incorporated do not affect the user directly, but have improved the handling of error situations.

COPY THROUGH BATCH

There appears to be some confusion about the use of the COPY command to produce disk files from cards.

Batch automatically deletes trailing blanks to make records shorter and processing faster, so that the effect of a COPY command through Batch would be to produce a file with no trailing blanks.

However COPY with the COMPRESS option is slightly different, and is intended for copying FORTRAN and MACRO program files. The COMPRESS option changes the contents of columns 73-80 (sequence numbers) to spaces and then deletes trailing blanks.

Users loading data cards containing useful information in columns 73-80 should not use the COMPRESS option.

## COMMAND LANGUAGE SPECIFICATIONS

[WN-57]

When running a program from an area other than your own, for example in Batch, a card of the form

.256.filename

should not contain any spaces. At present, the following problem will occur if spaces are included within the verb. The Command Decoder, when scanning and interpreting a card such as

.256Δ.Δfilename

will assume that the verb is 256.filename but it sets its pointer at the first non-blank character it finds, in this case

.256Δ.Δfilename

↑

The result is that the correct file is loaded for execution but the rest of the command is incorrectly taken to be the first input data record.

## OVERLAY COMMAND ERROR

[WN-57]

The command

OVERLAY(Ø) filename

gives the message 'OVERLAY SUBROUTINE NOT FOUND' at loading. To overcome this, users should compile the main program first, and thus have it on the loadlist when the first overlay command is given. This error will be fixed shortly.

## USE OF REWIND, ENDFILE AND CALL RELEASE STATEMENTS

[WN-57]

With the increased use of disk files, many users have reported getting the monitor message,

ERROR IN JOB n  
ADDRESS CHECK FOR DEVICE DSK; UDO AT USER location

This has in some cases been traced to excessive use of CALL RELEAS (n) statements which release the device but do not reclaim the memory locations used for buffers.

ENDFILE n statements should be used if the assignment of a filename to the logical device is not to be broken.

If another file is to be accessed on the logical unit, the programmer should use REWIND n.

For further details on the REWIND n and ENDFILE n statements, see the FORTRAN manual, MNT-5, and the Computer Centre Bulletin Vol.4, p.122.

### PDP-10 FORTRAN

[WN-59]

- (a) When attempting to skip records in a non-formatted disk file, it is necessary to include a dummy variable in the write statement, thus

```
READ(10) X is satisfactory but
READ(10) is not.
```

[WN-60]

- (b) The following FORTRAN statements do not compile correctly under version 23 of the FORTRAN compiler.

1300 U(I,J)=U(I,J)+L(K,I,1)*L(K,J,2)+L(K,I,2)*L(K,J,1)
1400 B=B+2.0*(LM(I,J,1)*H(J,I,1)+LM(I,J,2)*H(J,I,2))+U(I,J)*

While the FORTRAN manual does not explicitly state any limit to the length or complexity of a statement, users should attempt to avoid unnecessarily complicated statements. Failure to compile an expression usually occurs when it is very long or there are a number of subexpressions or subscript calculations to be performed.

### NEW FORTRAN OPERATING SYSTEM

[WN-56]

Version 30.2 of the FORTRAN operating system (LIB40) was released on Monday 27 September. The changes made in this version were primarily to correct errors reported following the initial release of the previous version, but a number of other improvements have been made, principally in the area of input/output control.

#### 1. IMPROVEMENT AND RATIONALIZATION OF INPUT/OUTPUT ERROR REPORTING

This affects the reporting of most input/output errors. For reference, the previous message as given in Vol.4 Nos 8 and 9 p.117 of the Bulletin, is quoted in parentheses.

If formatted input/output was in progress, each of these messages will be followed by the format statement (or the first 72 characters in the case of a large format statement). If it was found that the memory locations specified as the format statement did not contain a legitimate character string, then the message

FORMAT AT adr IS NOT A VALID CHARACTER STRING

will be output. Following this message, a line of the form

LAST FORTRAN I/O AT USER LOC adr

will be output.

DEVICE dev NOT AVAILABLE - LOGICAL UNIT n

(DEVICE dev: NOT AVAILABLE)

The operating system tried to initialize a device that either does not exist or has been assigned to another job.

END OF FILE, FILE name/ext DEVICE dev LOGICAL UNIT n

(END OF FILE ON dev)

A premature end-of-file has occurred on an input device.

Note that in the above and subsequent messages, a filename will be quoted only if it is relevant to the particular device. Further, it is not possible to give the extension part of the filename in all circumstances and in such cases the /ext will be omitted.

CANNOT FIND FILE name/ext DEVICE dev LOGICAL UNIT n

(FILE NAME filename NOT ON DEVICE dev)

The file cannot be found in the directory of the device that was accessed as logical unit n.

INPUT DEVICE ERROR, FILE name/ext DEVICE dev LOGICAL UNIT n

(INPUT DEVICE ERROR ON dev)

A data transmission error has been detected during input from the device accessed as logical unit n.

NO ROOM FOR FILE name/ext DEVICE dev LOGICAL UNIT n

(NO ROOM FOR FILE filename ON DEVICE dev)

There is no room for the file in the directory of the device accessed as logical unit n.



OUTPUT DEVICE ERROR, FILE name/ext DEVICE dev LOGICAL UNIT n  
(OUTPUT DEVICE ERROR ON dev)

A data transmission error has been detected during output to the device accessed as logical unit n.

PARITY ERROR, FILE name/ext DEVICE dev LOGICAL UNIT n  
(PARITY ERROR ON dev)

A parity error has been detected.

WRITE FAILURE FOR FILE name/ext DEVICE dev LOGICAL UNIT n  
(dev: WRITE PROTECTED)

The device is WRITE locked. This error can occur if a binary write operation is given after a read on the same logical unit.

LOGICAL UNIT n IS ILLEGAL  
(DEVICE NUMBER n IS ILLEGAL)

A non-existent unit number was selected.

In addition, the following messages that were not listed previously could occur under exceptional circumstances and are reported to complete the list of possible errors from the FORTRAN operating system.

RECORD TOO SHORT ON FILE name/ext DEVICE dev LOGICAL UNIT n  
(TAPE RECORD TOO SHORT ON UNIT dev)

The data list of a binary read operation exceeds the size of the logical record to be read.

BAD PHYSICAL RECORD COUNT, FILE name/ext DEVICE dev LOGICAL UNIT n  
(ILLEGAL PHYSICAL RECORD COUNT, TAPE dev)

There is an inconsistency in the format of the physical records of a binary logical record comprising more than 1 physical record.

END OF MEDIUM ON FILE name/ext DEVICE dev LOGICAL UNIT n  
(END OF TAPE ON dev)

This message would normally only occur when writing magnetic tapes and in this situation indicates end-of-tape.

ILLEGAL OPERATION, FILE name/ext DEVICE dev LOGICAL UNIT n  
(ILLEGAL MAGNETIC TAPE OPERATION, TAPE dev)

A non-permitted sequence of operations was attempted on the device.

?CANNOT FIND FOR302/SHR

The sharable FORTRAN operating system segment is not capable of being accessed.

?FOR302/SHR DOES NOT CORRESPOND TO IMP40

There is a problem in the organization of the System directory.

## 2. PRINTER CONTROL CHARACTERS

Additional characters can now be used for control of printer positioning on output. Previously only the characters +, blank, Ø, and l were correctly acted upon. The following characters now have the action indicated:

+	do not advance
1	preslew to VFU channel 1 - Top-of-form
2	preslew to VFU channel 2 - Bottom-of-form
3	preslew to VFU channel 3 - Half of form
4	preslew to VFU channel 4 - Third of form
5	preslew to VFU channel 5 - Sixth of form
6	preslew to VFU channel 6 - Single spacing over the whole page
7	preslew to VFU channel 7 - Top-of-page
-	preslew 3 lines*
Ø	preslew 2 lines*
blank	preslew 1 line*

(or any other character)

\* These three operations are obtained by repeated slewing to VFU Channel 8, continuing onto the next form if necessary.

The VFU (Vertical Format Unit) is controlled by a special tape, which has positions corresponding to each line in a page. As normally setup, a *page* is assumed to have 66 lines. Within a page, a *form* of 60 lines is centrally located. Within the page there will thus be a margin of 3 lines, a form of 60 lines, and a further margin of 3 lines. The VFU loop or tape has the following punchings:

Channel 1 - line 4  
 Channel 2 - line 61  
 Channel 3 - lines 4 and 34  
 Channel 4 - lines 4, 24 and 44  
 Channel 5 - lines 4, 14, 24, 34, 44 and 54  
 Channel 6 - all lines throughout the page  
 Channel 7 - line 1  
 Channel 8 - all lines between 4 and 63  
 (this channel is used for the -, Ø, and blank printer control characters).

Users should be aware that the only printer control characters defined for standard FORTRAN by the American Standards Institute are +, blank, Ø and l. The other control characters defined above are additional features for this installation and apply only to the line printer.

### 3. PLOTTING ROUTINES

Several changes have been made to the plotting routines, mainly to improve the handling of error conditions. No changes to functional programs should be necessary.

- (a) An attempt to run a program that does not contain a call to PLOTI will result in any other plotting routines used being undefined at loading and execution will be deleted.
- (b) If a pen movement call is given after a plot file is closed, the message 'NO PLOT FILE OPEN' is given. However, to prevent a large number of meaningless messages of this type, pen movement calls are merely ignored if they occur after the user program has regained control on an error.
- (c) After a 'COORDINATE OUT OF BOUNDS' error, the user program may now determine the coordinates of the offending point by calling WHERE, provided, of course, that the call to PLOTI included an error return statement number.
- (d) A call to SCALE with the number of points less than one will result in the message 'TOO FEW POINTS TO SCALE' instead of the less explicit 'FLOATING DIVIDE CHECK' and other messages that currently result from this condition. The results AMIN, and DA are set to zero and processing continues.

### 4. ERRORS CORRECTED

- (a) DEFINE FILE and CALL OFILE statements often produced files with extensions containing random characters. Both have been fixed. (See Weekly Newsletter No 53).
- (b) Loss of a character when inputting an ASCII string between single quotes no longer occurs. (See Weekly Newsletter No 53).

- (c) The 'Illegal character X, in format' now gives the offending character correctly.
- (d) Another attempt has been made to cure the problems caused by Batch removing the trailing blanks from data cards.
- (e) If a program running under Batch uses PAUSE, or has a source level error, the message 'TYPE G TO CONTINUE, X TO EXIT' is not given. Instead the program will exit immediately.
- (f) In Batch, a card with data up to column 78, with columns 79 and 80 blank caused the next input to have an extra leading blank. This problem has been fixed. (See Weekly Newsletter No 53).
- (g) All control characters, except carriage return, line feed, control-Z and tab are now ignored. The tab character is treated as a space, control-Z is the end of file character for terminals, and the carriage return and line feed are record separating characters. The file separator is now detected in all cases as the end of file character for Batch. (See Weekly Newsletter No 53).
- (h) As reported in Weekly Newsletter No 52 3(f) a repeated part of a format specification that did not use an item from the output list caused one to be ignored. This has been fixed so that

(2(/), 5F4.Ø)

will now work correctly.

WISP ON THE GE-225

[WN-60]

A new version of WISP has been implemented on the GE-225, which corrects some errors in the garbage collection scheme of compiler and execution package. Operational procedures are unaltered.

This new version has an extended set of standard forms and also uses a special version of MACRO GAP to simplify the definition of standard forms.

MULTIPLE LINEAR REGRESSION

[WN-61]

MLRP-SLIP on the GE-225 has been causing problems to a number of clients. It appears that BMDØ2R is a more satisfactory program for multiple linear regressions. BMDØ2R runs on the PDP-10 and can analyze data files created at a remote terminal or input through Batch.

Several BMD programs have been released for general use.

1. INTRODUCTION

Many problems require extensive analysis of large amounts of recorded data. As far as possible, the data handling processes should be made automatic and rapid and the Biomedical Computer Program (BMD) Series has been written for that purpose. These programs are provided in a 'package' form that enables users to effect their desired computations with simple coded instructions. The data is usually presented in a standard form, so that a wide variety of analyses may be carried out by specifying different parameters to various programs.

A number of these statistical programs, which were developed at the Health Sciences Computing Facility, UCLA, are now available on the PDP-10. The programs are batch-oriented but can be used from a terminal if great care is taken with data formats.

2. WRITE-UPS

The original writeups published in the BMD Manual, UCLA Press, 1968 have had to be modified slightly to conform with certain PDP-10 restrictions and to allow input from files as well as from card decks. These writeups each rely in some measure on the introductory descriptive material in the early chapters of the BMD manual. No attempt has been made here to provide a complete writeup for each separate program. Instead the user has been referred to the appropriate section in the BMD Manual and given the necessary changes required for the program to run on the PDP-10.

3. BMD MANUAL

The BMD manual 'Biomedical Computer Programs' is edited by W.J. Dixon. It is the second in a series of University of California Publications in Automatic Computation and is published by the University of California Press. There is a copy of the manual in the Engineering Library, and copies also exist at the Medical School in the following libraries; Social and Preventive Medicine, Microbiology, and Clinical Sciences.

4. RELEASE AND RUNNING OF PROGRAMS

BMD programs will be progressively converted and released, according to demand from users. Initially the following programs are available:

BMDØ1D	Simple Data Description
BMDØ2D	Correlation with Transgeneration
BMDØ8D	Cross Tabulation with Variable Stacking
BMDØ1M	Principal Component Analysis
BMDØ4M	Discriminant Analysis for Two Groups
BMDØ7M	Stepwise Discriminant Analysis
BMDØ2R	Stepwise Regression
BMDØ1V	One Way Analysis of Variance
BMDØ4V	Analysis of Covariance with Multiple Covariates

The programs are invoked by a single command following the .JOB card. The programs are in the \$BMD library and each has a filename derived from the last three identifying characters. For example, BMDØ1D has the filename DØ1, BMDØ4M is MØ4, BMDØ2R is RØ2, etc.

The command required to initiate BMDØ2R would therefore be

```
$BMD.RØ2
```

An up-to-date list of BMD programs available will be published from time to time in the Bulletin.

#### 5. PROGRAM CLASSIFICATION

The BMD programs are classified as Type 4 programs, which means that they are unsupported by the Computer Centre and are made available on a 'user beware' basis. (See Computer Centre Bulletin Vol.4 No 4, p.42). Although the Computer Centre is making these writeups available, no knowledge of the workings of each program is claimed by the Computer Centre personnel.

The programs are not guaranteed to work and, in general, no personal assistance will be given if a user has difficulty with a program.

However, the test data listed in the BMD Manual has been run with each program that has been released, and the results agree to within rounding error.

#### BMDØ1D

##### SIMPLE DATA DESCRIPTION

This program computes simple averages and measures of dispersion of variables, omitting those values which the user specifies for exclusion from the computations.

For a writeup of this program, consult 'Biomedical Computer Programs' edited by W.J. Dixon, pages 42-48, with the following exceptions:

#### (a) Blanks

Blanks are interpreted as zeros so methods 1 and 2 for specifying exclusion of blanks are not available.

(b) The Problem Card - PROBLM

- (i) Cols 69-70 Not used.
- (ii) Cols 73-74 Output device number, 1Ø for output to a disk file, FOR1Ø; otherwise, leave blank for output to the job output device.
- (iii) Cols 75-79 Input filename if data is on disk; otherwise, leave blank for input from the job input device.

BMDØ2D

CORRELATION WITH TRANSGENERATION  
(Boolean Selection of Cases)

This program computes simple correlation coefficients, averages and measures of dispersion on entering variables and/or transgenerated variables from selected cases whose values for specified variables have a precise logical relationship in agreement with a specified Boolean expression.

For a writeup of this program, consult 'Biomedical Computer Programs' edited by W.J. Dixon, pages 49-59, with the following exceptions:

(a) Limitations per problem

- (i) p, the number of original variables ( $2 \leq p \leq 100$ )
- (ii) g, the number of variables added to the original set after transgeneration ( $-98 \leq q \leq 98$ )
- (iii) k, the number of Variable Format Cards ( $1 \leq k \leq 8$ )

(b) The Problem Card - PROBLM

- (i) Cols 13-15 Number of original variables ( $2 \leq p \leq 100$ )
- (ii) Cols 23-26 +q q variables added to the original set after transgeneration ( $2 \leq p + q \leq 100$ )
- (iii) Cols 33-34 Not used
- (iv) Cols 69-70 Not used
- (v) Cols 71-72 Number of Variable Format Cards ( $1 \leq k \leq 8$ )
- (vi) Cols 73-74 Output device number, 1Ø for output to a disk file, FOR1Ø; otherwise, leave blank for output to the job output device.
- (vii) Cols 75-79 Input filename if data is on disk; otherwise, leave blank for input from the job input device.

(c) Plot Selection Card - PLOTSL

- (i) Cols 10-11 Number of variables to be cross-plotted with this base variable ( $\leq 10$ ).



BMDØ8D

CROSS-TABULATION WITH VARIABLE STACKING

This program computes two-way frequency tables of data input. Frequency tables are computed from specified ranges of the original variables, variables after transgeneration, stacked variables, or combinations of these. Data input may be positive or negative integers only. The program will not accept data input fields that have a punched decimal point.

For a writeup of this program, consult 'Biomedical Computer Programs' edited by W.J. Dixon, pages 109-119, with the following exceptions.

(a) Limitations per problem

- (i) The limitation on the maximum value of each data item is  $\pm 1 \times 10^{38}$  approximately.

(b) The Problem Card - PROBLM

- (i) Cols 23-25 Note that  $N(p+q) \leq 8,000$ ,  $p+q \leq 100$
- (ii) Cols 73-74 Output device number, 1Ø for output to a disk file, FOR1Ø; otherwise, leave blank for output to the job output device.
- (iii) Cols 75-79 Input filename if data is on disk; otherwise, leave blank for input from the job input device.

BMDØ1M

PRINCIPAL COMPONENT ANALYSIS

This program computes the principal components of standardized data and rank orders each standardized case by the size of each principal component separately.

For a writeup of this program, consult 'Biomedical Computer Programs' edited by W.J. Dixon, pages 150-158, with the following exceptions:

(a) Limitations per problem

- (i) n, number of cases ( $3 \leq n \leq 220$ )

(b) The Problem Card - PROBLM

- (i) Cols 15-17 Number of cases ( $3 \leq n \leq 220$ )
- (ii) Cols 71-72 Number of Variable Format Card(s) ( $1 \leq k \leq 8$ )
- (iii) Cols 73-74 Output device number, 1Ø for output to a disk file, FOR1Ø; otherwise, leave blank for output to the job output device.
- (iv) Cols 75-79 Input filename if data is on disk; otherwise, leave blank for input from the job input device.

## BMD04M

### DISCRIMINANT ANALYSIS FOR TWO GROUPS

This program computes a linear function of p variables measured on each individual of two groups. This function can serve as an index for discrimination between the groups. It is determined from the criterion of 'best' in that the difference between the mean indices for the two groups divided by a pooled standard deviation of the indices is maximized.

### STEPWISE DISCRIMINANT ANALYSIS

This program performs a multiple discriminant analysis in a stepwise manner. At each step one variable is entered into the set of discriminating variables. The variable entered is selected by the first of the following equivalent criteria:

- (1) The variable with the largest F value (see computational procedure).
- (2) The variable that when partialled on the previously entered variables has the highest multiple correlation with the groups.
- (3) The variable that gives the greatest decrease in the ratio of within to total generalized variances.

A variable is deleted if its F value becomes too low. The program also computes canonical correlations and coefficients for canonical variables. It plots the first two canonical variables to give an optimal two-dimensional picture of the dispersion.

STEPWISE REGRESSION

This program computes a sequence of multiple linear regression equations in a stepwise manner. At each step one variable is added to the regression equation. The variable added is the one that makes the greatest reduction in the error sum of squares. Equivalently it is the variable that has highest partial correlation with the dependent variable partialled on the variables that have already been added; and equivalently it is the variable which, if it were added, would have the highest F value. In addition, variables can be forced into the regression equation. Non-forced variables are automatically removed when their F values become too low. Regression equations with or without the regression intercept may be selected.

ANALYSIS OF VARIANCE FOR ONE-WAY DESIGN

This program computes an analysis-of-variance table for one variable of classification, with unequal group sample sizes. Optionally data may be read in from a file.

ANALYSIS OF COVARIANCE WITH MULTIPLE COVARIATES
