

Statement of Limited Warranty (Machine)

The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you originally purchase for your use, and not for resale, from IBM or an IBM authorized reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. Machines are subject to these terms only if purchased in the United States or Puerto Rico, or Canada, and located in the country of purchase. If you have any questions, contact IBM or your reseller.

Machine: IBM ARTIC960 PCI Co-Processor Platform

Warranty Period*: This Feature assumes the Warranty period of the IBM host in which it is installed. For all other conditions, the Warranty period is three years.

*Elements and accessories are warranted for three months. Contact your place of purchase for warranty service information.

Production Status

Each Machine is manufactured from new parts, or new and serviceable used parts (which perform like new parts). In some cases, the Machine may not be new and may have been previously installed. Regardless of the Machine's production status, IBM's warranty terms apply.

The IBM Warranty

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. IBM calculates the expiration of the warranty period from the Machine's Date of Installation. The date on your receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period, IBM or your reseller will provide warranty service under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine. IBM or your reseller will specify the type of service.

For a feature, conversion, or upgrade, IBM or your reseller may require that the Machine on which it is installed be 1) the designated, serial-numbered Machine and 2) at an engineering-change level compatible with the feature, conversion, or upgrade. Some of these transactions (called "Net-Priced" transactions) may include additional parts and associated replacement parts that are provided on an exchange basis. All removed parts become the property of IBM and must be returned to IBM.

Replacement parts assume the remaining warranty of the parts they replace.

If a Machine does not function as warranted during the warranty period, IBM or your reseller will repair or replace it (with a Machine that is at least functionally equivalent) without charge. If IBM or your reseller is unable to do so, you may return it to your place of purchase and your money will be refunded.

If you transfer a Machine to another user, warranty service is available to that user for the remainder of the warranty period. You should give your proof of purchase and this Statement to that user.

Warranty Service

To obtain warranty service for the Machine, you should contact your reseller or call IBM. In the United States, call IBM at **1-800-IBM-SERV (426-7378)**. In Canada, call IBM at **1-800-465-6666**. You may be required to present proof of purchase.

Depending on the Machine, the service may be 1) a "Repair" service at your location (called "On-site") or at one of IBM's or a reseller's service locations (called "Carry-in") or 2) an "Exchange" service, either On-site or Carry-in.

When a type of service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced.

It is your responsibility to:

- 1. obtain authorization from the owner (for example, your lessor) to have IBM or your reseller service a Machine that you do not own;

This book is written for an experienced computer operator or a person who sets up, uses, or programs the IBM ARTIC960 PCI Co-Processor Platform with a PCI (peripheral component interconnect) computer.

– Terminology Note -

Throughout this book, the IBM ARTIC960 PCI Co-Processor Platform also is referred to as the *co-processor platform* or the *co-processor adapter*, interchangeably.

Chapter 1. Product Description

The IBM ARTIC960 PCI Co-Processor Platform is a programmable adapter that can be used with any full-size 32-bit, 5 volt, PCI/ISA or PCI/Micro Channel-compliant computer. This co-processor adapter supports the off-loading of real-time tasks from the system processor and provides bus-mastering capabilities for peer-to-peer transfers across the PCI bus.

The IBM ARTIC960 PCI Co-Processor Platform is shipped with a minimum of 1MB of instruction memory and without packet memory. At least 1MB of packet memory must be installed for the adapter to function. Plug-in packet memory modules are available in options of 1, 4, 8, and 16MB increments.

The co-processor adapter has the following standard features:

- 32-bit (25 MHz) microprocessor, Intel 80960C-Series
- Dynamic random-access memory (DRAM) error checking and correction for improved data accuracy
- Adapter-to-system or adapter-to-adapter bus master transfers
- · Generic AIB interface for multipurpose applications
- Operating system driver included with the adapter.

The co-processor adapter is designed to permit application interface boards (AIBs) developed by either IBM or third parties to interface with the co-processor adapter without requiring any modification to the adapter. The AIB attaches to the co-processor adapter through a 140-pin connector. Interface signals exit the AIB through a multipin connector at the rear of this board. The co-processor adapter and the attached AIB occupy just one 32-bit expansion slot.

A set of operating system packages is available electronically; each contains ARTIC960 drivers and utilities to support a runtime environment for a particular operating system such as OS/2 or AIX.

Another electronically available software package is the **Developer's Kit**. The Developer's Kit is a set of publications and programs designed to help ARTIC960 AIB software developers develop for the ARTIC960 platform. The following items make up the Developer's Kit:

- *IBM ARTIC960 Co-Processor Platform Hardware Technical Reference* presents technical details of the adapter's system, options, and hardware interfaces. It provides descriptions and data related to the card configuration, functions, hardware interfaces, and programming considerations.
- *IBM ARTIC960 Co-Processor Platforms Programmer's Guide and Reference* provides an overview of both the adapter kernel support and the operating system support. It also describes the associated processes and utilities, as well as each of the services provided by the system unit support and the adapter kernel support.
- *IBM ARTIC960 Co-Processor Platform Application Interface Board Developer's Guide* provides the hardware and the software developer with AIB design requirements, and a collection of productivity tools to aid in the development of an AIB.
- A set of operating system packages, each containing sample programs and utilities to support the development of system unit and adapter applications. These packages are to be used with the *IBM ARTIC960 Co-Processor Platforms Programmer's Guide* and the *IBM ARTIC960 Co-Processor Platform Application Interface Board Developer's Guide*.

Chapter 2. Installation

This chapter lists the contents of the IBM ARTIC960 PCI Co-Processor Platform package, and provides the hardware installation requirements and information for setting up and installing the co-processor adapter. Each IBM ARTIC960 PCI Co-Processor Platform package includes the following:

- IBM ARTIC960 PCI Co-Processor Platform, containing 1MB of instruction memory and no packet memory. (At least 1MB of packet memory must be installed on the co-processor adapter.)
- Guide to Operations book (with Warranty Statement).

Options

Packet memory modules, application interface boards (AIBs), interface cables for the AIBs, and wrap plugs are available as options. Refer to the 4-Port Multi-Interface Application Interface Board Supplement to the Guide to Operations for the IBM ARTIC960 Co-Processor Platform/IBM ARTIC960 PCI Co-Processor Platform for a description of the IBM-developed AIBs and associated cabling accessories.

Installation Requirements

The FCC statement in Appendix B, "Notices" may be different than the FCC statement in the manual that came with your system. Use the FCC statement in this manual for the system unit that will contain the IBM ARTIC960 PCI Co-Processor Platform.

Hardware Requirements for IBM Computers

The IBM ARTIC960 PCI Co-Processor Platform requires a full-length, 5-volt, 32-bit slot. It can be installed into any PCI/ISA or PCI/Micro Channel-compliant computer.

Handling Static-Sensitive Devices

Components for your co-processor adapter can be damaged by static discharges. To prevent this damage, your co-processor adapter is wrapped in an anti-static bag. Observe the following precautions when handling the co-processor adapter.

- Keep the adapter in its anti-static bag until you are ready to install it.
- Make the least possible movement with your body to minimize the electrostatic charges created by contact with clothing fibers, carpet, and furniture.
- If possible, keep one hand on the computer chassis when you are inserting or removing the adapter. Always switch off power before removing an adapter from the system unit.
- Do not touch the printed circuit. Where possible, hold the adapter by its plastic end pieces or by its edges, but do not touch the metal edge connectors.
- Do not place the adapter on the machine cover or on a metal table. Machine covers and metal tables increase the risk of damage because they make a discharge path from your body through the adapter.

Installation Instructions


Note: Before performing any hardware installation, read "Handling Static-Sensitive Devices."

Use the steps that follow to perform the hardware installation tasks appropriate for your computer system.

Note: For some RISC System/6000 system installations, the Packet Memory Module, the Co-Processor Platform, and the AIB are supplied already assembled as one unit.

Step 1: Install the Optional Packet Memory Module onto the Co-Processor Platform

- 1. Hold the co-processor adapter (still wrapped in the anti-static bag) in one hand and touch a metal part of your system unit with the other hand. This places your body and the co-processor adapter at the same ground potential, thereby preventing an accidental static discharge.
- Carefully remove the co-processor adapter and the packet memory module from their respective anti-static packages. Be sure to grasp these items by the edges only; do not touch the component pins or solder joints.
- 3. Hold the packet memory module 2 (as shown) with the notch
 1 on the right, facing towards the handle of the co-processor adapter.
- 4. Insert the packet memory module at an angle (approximately 45°) into the connector **3**.
- Place your thumbs on the top corners of the packet memory module; press it towards the co-processor adapter until the memory module snaps into the retainer clips

Step 2: Configure AIB Bracket and Stiffener




Figure 2-1. PCI/ISA Bracket and Stiffener

The bracket and stiffener attached to your AIB should look like those in Figure 2-1.


If they do not look like this illustration, do the following.

- 1. Carefully remove the AIB from its anti-static bag. Remember to grasp the circuit board by the edges only; do not touch the components or the solder joints.
- 2. Remove the L-shaped PCI/ISA bracket and PCI stiffener from the plastic bag.
- 3. Using a 3/16-inch hex nut driver, remove the bracket and stiffener currently attached to the AIB, and store them in a safe place.
- 4. Using the 3/16-inch hex nut driver and the hex screws and washers you removed in the previous step, attach the PCI/ISA bracket and stiffener so it looks like Figure 2-1.


For information concerning the functional pin assignments and technical details of the 140-pin connector (AIB interface) on the co-processor adapter, refer to the *IBM ARTIC960 Co-Processor Platform Hardware Technical Reference* manual.

Step 3: Install the AIB onto the Co-Processor Platform


1. Verify that the jumper plug on **P4** of the co-processor adapter is installed between pins 1 and 2. (A new co-processor adapter is shipped this way.)



2. The AIB attaches to the co-processor adapter with four screws. Only two of the screws have to be removed from the AIB during the installation procedure; however, the other two screws must be loosened a few turns to allow the slots in the co-processor adapter to slide under the screw heads. As shown in the following figure, loosen two screws, and then remove the two screws from the standoffs on the component side of the AIB.




3. Slide the co-processor adapter over the AIB standoffs containing the screws.




- 4. Align the connector on the AIB with the mating connector on the co-processor adapter.
- 5. Inspect the alignment of the two connectors to ensure they are mating correctly. Misalignment could cause damage to the co-processor adapter and the AIB.
- 6. Firmly press the AIB and the co-processor adapter connectors together.

7. Insert the two screws through the two holes of the co-processor adapter and finger-tighten these screws.



8. Tighten all four screws on both sides of the co-processor adapter AIB assembly, but do not overtighten them.



Step 4: Install the Co-Processor Platform and Attached AIB into the System Unit

- **Note:** For specific cover removal and adapter installation instructions, refer to the Operating and Installation documentation provided with your computer system.
- 1. Set all power switches for your system unit to Off.
- 2. Unplug the power cords from the electrical outlets.
- 3. Disconnect all cables from the rear of the system unit.
- 4. Remove the system unit cover.
- 5. Locate an available 32-bit expansion slot in your system unit that supports a full-length PCI adapter card.
- 6. Loosen the expansion-slot screw and remove the expansion-slot cover.
- Install the co-processor adapter and attached AIB by firmly pressing it into the expansion-slot connector until it clicks into place.
- 8. Before tightening the expansion-slot screw, ensure there is no interference with adjacent expansion-slot screws. Then tighten the expansion-slot screw to lock the co-processor adapter in place.
- If you have other adapters (or options) to install, do so now. Refer to the Operating and Installation documentation provided with your computer system if more information is required for the other adapters or options.
- 10. Replace the system unit cover.
- 11. Reconnect all cables previously removed from the system unit.
- 12. Plug all power cords into electrical outlets.

Step 5. Download the Diagnostics and Operating System Support Programs

Diagnostics and support programs for various operating systems are available with the purchase of this card. Specific operating system support programs can be obtained through either the World Wide Web (WWW) or the Bulletin Board System (BBS).

Note: The IBM ARTIC960 Platforms Operating System Support Programs have no compatible interfaces to prior IBM Realtime Interface Co-Processors.

Problem Determination Procedures

For system testing information, refer to the manual supplied with your computer.

If you performed the diagnostic tests because of a suspected communications problem and have successfully completed the tests without an error message, additional testing may be required on the following:

- Host computer, industrial computer, or device with which you are trying to communicate (such as a printer)
- Communications link
- · Attached communications devices, such as a modem
- Communications cable.

To test the ARTIC960 PCI adapter or an AIB attached to an ARTIC960 PCI Adapter, refer to the operating system support programs you downloaded from the WWW or BBS in "Step 5. Download the Diagnostics and Operating System Support Programs" on page 2-10. If no problems are found, have the system unit serviced.


Chapter 3. AIB Removal Procedure

To remove an AIB from an ARTIC960 PCI adapter, do the following.


- 1. Set all power switches for your system unit to Off.
- 2. Unplug the power cords from the electrical outlets.
- 3. Disconnect all cables from the rear of the system unit.
- 4. Remove the system unit cover.
- 5. Locate the assembled co-processor adapter (containing the suspect AIB) in your system unit and record the slot number.
- 6. Loosen the expansion-slot screw that locks the assembled co-processor adapter in place.
- 7. Remove the assembled co-processor adapter from the system unit by grasping the handle and the connector bracket, and pulling upward.
 - **Note:** Be sure to hold the assembled co-processor adapter by the edges only; do not touch the component pins or solder joints.
- 8. Remove the four screws on the assembled co-processor adapter. (The two cards are still held together by the AIB connector.)

Attention:

Do not attempt to expedite the removal by simply *loosening* the two screws in the slotted holes. Damage could result when you attempt to separate the two cards.



 Carefully separate the AIB from the co-processor adapter. (Remember, the two cards are held together by the AIB connector near the bottom of each card.)




- 10. Reinstall just the co-processor adapter into the same slot recorded in Step 5 of this procedure.
- 11. Reinstall the system unit cover.
- 12. Reconnect all cables previously removed from the system unit.

- 13. Plug all power cords into electrical outlets.
- 14. Switch on power to your computer system.






