Chapter 1. Setting up your computer

Before you begin Be sure to read "Safety notices" on page v.

Selecting a location for your computer

Make sure you have an adequate number of properly grounded electrical outlets for all devices. Select a location for the computer where it will remain dry. Leave about 50 mm (2 in.) of space around the computer for proper air circulation.

Arranging your workspace

Arrange both the equipment and your work area to suit you. Light sources, air circulation, and the location of electrical outlets can affect how you arrange your workspace.

Comfort

The following guidelines will help you decide what working position suits you best.

Choose a chair to reduce fatigue from sitting in the same position for long periods. The backrest and seat should adjust independently and provide good support. The seat should have a curved front to relieve pressure on the thighs. Adjust the seat so that your thighs are parallel to the floor and your feet are either flat on the floor, or on a footrest.

When using the keyboard, keep your forearms parallel to the floor and your wrists in a neutral, comfortable position. Try to keep a light touch on the keyboard, and your hands and fingers relaxed. Change the angle of the keyboard for maximum comfort by adjusting the position of the keyboard feet.



Adjust the monitor so that the top of the screen is at, or slightly below, eye level. Place the monitor at a comfortable viewing distance, usually 51 to 61 cm (20 to 24 in.), and position it so that you can view it without having to twist your body.

Glare and lighting

Position the monitor to minimize glare and reflections from overhead lights, windows, and other light sources. Place the monitor at right angles to light sources whenever possible. Reduce overhead lighting, if necessary, by turning off lights or using lower wattage bulbs. If you install the monitor near a window, use curtains or blinds to block the sunlight. You might have to adjust the Brightness and Contrast controls on the monitor as the lighting changes throughout the day.

Where it is impossible to avoid reflections or to adjust the lighting, place an antiglare filter over the screen. However, these filters might affect the clarity of the screen image; try them only after you have exhausted other methods of reducing glare.

Dust compounds problems associated with glare. Clean your monitor screen periodically using a soft cloth moistened with a nonabrasive, liquid glass cleaner.

Air circulation

Your computer and monitor produce heat. The computer fan pulls in fresh air and forces out hot air. The monitor lets hot air escape through vents. Blocking the air vents can cause overheating, possibly resulting in malfunction or damage. Place the computer and monitor so that nothing blocks the air vents; usually 50 mm (2 in.) of air space is sufficient. Also, make sure the vented air is not blowing on someone else.

Electrical outlets and cable lengths

The location of electrical outlets and the length of device power cords and cables might determine the final placement of your computer.

When arranging your workspace:

- Avoid the use of extension cords. Whenever possible, plug the computer power cord directly into an electrical outlet.
- Keep power cords and cables neatly routed away from walkways and other areas where they might be accidentally dislodged.

For more information about power cords, see "Power cord notice" on page 47.

Connecting cables

Refer to the illustration in "Connectors" on page 5 for locating cable connectors. Match the cable connector with the connector on the computer. Read the following before connecting cables:

- Connect all device cables before inserting any power cords into an electrical outlet.
- Connect the power supply to the computer before connecting it to an electrical outlet.
- Connect the power cords to the computer and to the other devices before inserting them into an electrical outlet.

Important

To operate the computer within FCC limits, use a Category 5 Ethernet cable.

USB connectors

There are six USB connectors on your computer. Two are located on the top rear of the monitor. The other four USB connectors are at the lower rear of the computer near the power supply connector. Connect the USB keyboard and mouse to the USB ports.

Some models of the Rapid Access III keyboard and the Rapid Access III Wireless keyboard have USB connectors at the rear of the keyboard. Use the software that comes with the keyboard. The software will also include a Portable Document Format (.PDF) of the keyboard *User's Guide*. Consult this publication for using the USB connectors on the keyboard.

The IBM° Rapid Access III Wireless keyboard and ScrollPoint $^{\circ}$ Wireless mouse come with an IBM Dual Wireless Receiver. Connect the receiver into one of the

USB connectors at the rear of the computer. The Rapid Access Wireless Keyboard and the ScrollPoint Wireless Mouse operate with this receiver.

Notes:

- 1. Cable connectors for USB devices only fit one way. They cannot be connected incorrectly.
- 2. The USB connectors on the Rapid Access III keyboard and Rapid Access III Wireless keyboard are designed only for small USB devices.
- **3**. USB devices, such as speakers or an unpowered USB hub, should be connected to one of the USB connectors on the computer.
- 4. Do not place the IBM Dual Wireless Receiver on top of the power supply.

Controls and status indicators

Each button at the front of your computer controls a specific function, such as turning on the computer. The lights are status indicators that tell you when a certain device, such as the diskette drive, is in use.



The following is a description of the controls and status indicators for your computer.

Hard disk drive in-use indicator: When this light is on, it indicates that the hard disk drive heads are being positioned or that your computer is reading from or writing to the hard disk. Do not turn off your computer when this indicator is on or blinking.

Power/standby indicator: This status indicator is on when power to your computer is turned on.

Power button: Press this button to turn your computer on or off. Do not turn off your computer if the in-use indicator for the hard disk drive or diskette drive is on.

Note: The power button normally operates with a single touch. However, in some circumstances the computer might not immediately turn off. If this happens, hold the power button down for approximately five seconds, and the computer will then turn off.

LCD brightness decrease button: Press and hold this switch until the monitor brightness is decreased to the desired level.

LCD brightness increase button: Press and hold this switch until the monitor brightness is increased to the desired level.

Device bay release button: Press this button to lower the device bay for access to the diskette drive and the CD-ROM or DVD-ROM drive. To close it, push upward on the device bay until it latches in the closed position.

CD-ROM or DVD-ROM eject button: Press this button on the CD-ROM or DVD-ROM drive to open the tray for inserting or removing a disc.

Turning on power

Turn on the computer. When the self-test is done, the IBM logo window closes. If your computer has preinstalled software, the software installation program begins.

If you experience any problems during startup, refer to "Chapter 2. Recovery and troubleshooting" on page 11 and "Chapter 3. Getting information, help, and service" on page 21.

Finishing the software installation

After you start the computer for the first time, follow the instructions on the screen to complete the software installation. If you do not complete the software installation the first time the computer is turned on, unexpected results might occur. Once the installation is complete, click **Start →Access IBM** on your screen for more information about your computer.

Software Selections CD

The *Software Selections CD* contains application programs and support software for use with your computer. Insert the *Software Selections CD* into your CD or DVD drive and follow the instructions on the screen.

You can use the CD to:

- Install software products or documentation directly from the CD on models equipped with a CD drive.
- Create an image of the *Software Selections CD* on your hard disk or on a local area network (LAN) disk and install the software products from that image.

The *Software Selections CD* has an easy-to-use, graphical interface and automated installation procedure for most programs. It also has a help system that describes the features of the CD.

For more information about installing software from the *Software Selections CD*, go to Access IBM.

Other operating systems

If you install your own operating system, follow the instructions that come with your operating system CDs or diskettes. Remember to install all device drivers after you install your operating system. Installation instructions are provided with or on the CDs or diskettes, or in the README files.

Shutting down the computer

When you are ready to turn off your computer, always follow the shut down procedure. This prevents the loss of unsaved data or damage to your software programs. To shut down Windows:

- 1. Click Start on the Windows desktop.
- 2. Click Shut Down.
- 3. Select Shut down.
- 4. Click OK.

Accessing and printing the User Guide

The *User Guide* for your computer has information about installing optional hardware. This (.pdf) file can be accessed through Access IBM. It can be viewed using Adobe Acrobat Reader and printed for use when installing optional hardware.

Recording your computer information

Recording information about your computer can be helpful if you ever need your computer serviced. The service technician will likely ask you for this information.

The machine type (M/T), model number and serial number (S/N) are labeled on your computer. Use the following table to record this information:

You can register your computer by telephone when you call for service and support. Go to Access IBM for more information about registering your computer.

Chapter 2. Recovery and troubleshooting

If you are having a problem with your computer, this chapter describes some basic software recovery tools. Go to the online *User Guide*, available through Access IBM, for more information about troubleshooting or diagnosing a problem.

The Product Recovery program will reinstall your computer operating system and factory-installed software. It is on a separate hidden partition on the hard disk. The Product Recovery program runs independently of the operating system.

Performing a recovery

Important

Understand the following information before recovering your software:

- Perform a recovery only as a last resort after all other diagnostic and troubleshooting tools have been exhausted.
- If possible, back up your data files before starting the recovery process. The recovery process deletes all information that is stored on the primary hard disk partition (usually drive C).
- The Product Recovery program on the hard disk partition is the primary method to perform recovery procedures.
- If you are performing a recovery because the computer hard disk drive was replaced, see "Software recovery after a hard disk failure" on page 12.

To perform a recovery, use the following procedure:

- 1. Make backup copies of your data files, if possible. Any files on the hard disk that are not backed up will be lost.
- 2. Turn off your computer for at least 5 seconds. Press and hold the F11 key while you press the power button. The Product Recovery program will start. Continue with step 5.

If you did not see the Product Recovery program, but instead saw the operating system or the IBM Setup Utility¹, exit this program and turn off the computer for at least 5 seconds. Restart the computer. When you see the prompt, To begin the IBM Product Recovery Program, press F11, quickly press the F11 key. It is displayed for only a few seconds.

^{1.} In some models, this program is called the Configuration/Setup Utility program.

Was the F11 prompt displayed?

Yes - Go to step 3.

No - Either your computer does not have the Product Recovery program on the hard disk or the F11 prompt is damaged. Go to "Solving recovery problems" on page 13.

Did the Product Recovery program start after you pressed F11?
 Yes - Go to step 5.

No - If you have a *Product Recovery CD*, go to step 4. Otherwise, go to "Solving recovery problems" on page 13.

- 4. Insert the *Product Recovery CD* into the CD drive (if you have more than one CD, insert CD 1). Restart the computer. If the computer does not start the Product Recovery program from the CD, you might not have your CD drive or DVD drive listed in the startup sequence. Set your CD drive or DVD drive as the first device in the startup sequence. See "Changing the startup sequence" on page 14 for details.
- 5. When the Product Recovery program starts, you might have the opportunity to select an operating system. If a menu of operating systems is displayed, use the arrow keys to select the appropriate operating system, and press Enter.
- **6.** Follow the instructions on the screen. Your computer might restart during the recovery process, possibly more than once. When the recovery process is finished, a completion message is displayed.

Notes:

- 1. After recovery, you might have to reinstall device drivers for some devices. If you need to reinstall device drivers, see "Recovering or installing device drivers" on page 14.
- 2. Some computers come with Microsoft Office or Microsoft Works preinstalled. If you need to recover your Microsoft Office or Microsoft Works applications, you must use the *Microsoft Office CD* or *Microsoft Works CD*. These CDs are provided only with computers that come with Microsoft Office or Microsoft Works preinstalled.

Software recovery after a hard disk failure

When the hard disk drive is replaced because of a failure, no Product Recovery program is on the new hard disk. In this case, you must use the *Product Recovery CD* for your computer. If you have a *Product Recovery CD*, go to step 4 above for instructions for recovering the software. If a *Product Recovery CD* was not provided with your computer, contact IBM and order a *Product Recovery CD* for your computer. See "Chapter 3. Getting information, help, and service" on page 21 for details.

Solving recovery problems

Use the information in this section if you are unable to access the Product Recovery program.

F11 will not start the Product Recovery program

Either the Product Recovery program is damaged, or there is a problem with the partition that contains the Product Recovery program. Use a *Product Recovery CD* to access the Product Recovery program. If a *Product Recovery CD* was not provided with your computer, contact IBM, and order a *Product Recovery CD* for your computer. See "Chapter 3. Getting information, help, and service" on page 21 for details.

The Product Recovery CD does not start

Make sure that the CD drive or DVD drive is before the hard disk drive in the startup sequence. See "Changing the startup sequence" on page 14.

The F11 prompt is not displayed

Use your *Recovery Repair* diskette to recover the F11 prompt, or create a *Recovery Repair* diskette, if you do not have one. See "Using the Recovery Repair diskette" or "Creating a Recovery Repair diskette" for how to display the F11 prompt.

Creating a Recovery Repair diskette

Note: This procedure works only if the operating system is working. To create a *Recovery Repair* diskette, use the following procedure:

- 1. Start your computer and operating system.
- 2. Use Windows Explorer or My Computer to display the directory structure of your hard disk.
- 3. Open the imbtools folder, which is usually on drive C.
- 4. Double-click RRDISK.BAT, and follow the instructions on the screen.

Using the Recovery Repair diskette

To use the Recovery Repair diskette, use the following procedure:

- 1. Shut down the operating system, and turn off the computer.
- 2. Insert the *Recovery Repair* diskette into the diskette drive.
- 3. Turn on the computer, and follow the directions on the screen

Note: If the repair operation finishes without error, the F11 prompt will be displayed the next time you restart your computer.

If an error message is displayed during the repair operation and the repair operation cannot be completed, you might have a problem with the Product Recovery program or the partition that contains the Product Recovery program. Use a *Product Recovery CD* to access the Product Recovery program. If a *Product Recovery CD* was not provided with your computer, contact IBM, and order a *Product Recovery CD* for your computer. See "Chapter 3. Getting information, help, and service" on page 21 for details.

Changing the startup sequence

If you inserted a CD into the CD or DVD drive and your computer does not read the CD immediately on startup, change the first device in the startup sequence to the CD or DVD drive. To change the startup sequence, use the following procedure:

- 1. Turn off your computer.
- 2. Turn on your computer.
- **3**. When the IBM Setup Utility program prompt is displayed, quickly press F1. The prompt is displayed for only a short time.
- 4. From the IBM Setup Utility menu, select Startup or Start Options.
- 5. Note the device that is currently selected as the first startup device, and write it down for future reference. You must restore this setting when you have completed the recovery process.
- 6. Change the first startup device to your CD drive or DVD drive.
- 7. Save the settings, and exit from the program.
- 8. Turn off your computer.

Recovering or installing device drivers

Before you can recover or install device drivers, your operating system must be installed on your computer. Make sure that you have the documentation and software media for the device.

Device drivers for IBM-installed devices are located on the computer hard disk (usually drive C) in the ibmtools\drivers folder. The instructions for installing device drivers (readme.txt) are also located in the ibmtools\drivers folder. Other device drivers are on the software media that come with individual devices.

The latest device drivers for IBM-installed devices are also available on the World Wide Web at http://www.ibm.com/pc/support/.

To recover a device driver for an IBM-installed device, use the following procedure:

- 1. Start your computer and operating system.
- 2. Use Windows Explorer to display the directory structure of your hard disk.

- 3. Open the ibmtools folder.
- 4. Open the drivers folder. Within the drivers folder are several subfolders that are named for various devices that are installed in your computer (for example, audio, video, and so on).
- 5. Open the appropriate subfolder.
- 6. Use one of the following methods to recover the device driver:
 - a. In the device subfolder, look for a readme.txt file or other file with the .txt extension that contains information about reinstalling the device driver. This file might be named after the operating system, such as win98.txt. Follow the instructions in this file.
 - b. If the device subfolder contains a file with an .inf extension, you can use the Add New Hardware program (located in the Windows Control Panel) to reinstall the device driver. Not all device drivers can be reinstalled using this program. In the Add New Hardware program, when prompted for the device driver that you want to install, click Have Disk and Browse. Then select the appropriate device-driver (.inf) file from the device subfolder.
 - c. In the device subfolder, look for a setup.exe file. Double-click **SETUP.EXE**, and follow the instructions on the screen.

Basic troubleshooting

The tables in this section describe some basic computer problems and error codes, as well as actions you can take.

If the problem persists, or is not listed in this section, more detailed troubleshooting might be required. See Access IBM for more detailed troubleshooting information.

Error codes

Working with error codes often means checking or making changes to settings in the IBM Setup Utility. To access this program, press F11 during startup.

- 2. If you get multiple error codes, always work in the order in which the error codes are displayed.
- **3**. If the error code is not in the following table, more in-depth troubleshooting is required.
 - Use the IBM Enhanced Diagnostics program. If your computer starts, use F11 to access the Recovery Program, then select IBM Enhanced Diagnostics. The IBM Enhanced Diagnostics tool will help to further detect and isolate problems. See the troubleshooting procedures in your online *User Guide*, available through Access IBM.
 - If the operating system will not start, have the computer serviced.

IBM maintains pages on the World Wide Web where you can get the latest technical information and download device drivers and updates. Calling for service

If you have tried to correct the problem yourself and still need help, during the warranty period, you can get help and information by telephone through the IBM PC HelpCenter[®]. The following services are available during the warranty period:

- **IBM hardware repair** If the problem is determined to be caused by IBM hardware under warranty, trained service personnel are available to provide the applicable level of service.
- Engineering Change management Occasionally, there might be changes that are required after a product has been sold. IBM or your reseller, if authorized by IBM, will make selected Engineering Changes (ECs) available that apply to your hardware.

The following items are not covered:

- Replacement or use of non-IBM parts or nonwarranted IBM parts. All warranted parts contain a 7-character identification in the format IBM FRU XXXXXX.

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

Extent of Warranty

The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION

OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

Items Not Covered by Warranty

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND.**

Warranty Service

To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Some parts of IBM Machines are designated as Customer Replaceable Units (called "CRUs"), e.g., keyboards, memory, or hard disk drives. IBM ships CRUs to you for replacement by you. You must return all defective CRUs to IBM within 30 days of your receipt of the replacement CRU. You are responsible for downloading designated Machine Code and Licensed Internal Code updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features,

conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

- 1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;
- 2. obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and
- 3. where applicable, before service is provided:
 - a. follow the problem determination, problem analysis, and service request procedures that IBM or your reseller provides;
 - b. secure all programs, data, and funds contained in a Machine;
 - c. provide IBM or your reseller with sufficient, free, and safe access to your facilities to permit them to fulfill their obligations; and
 - d. inform IBM or your reseller of changes in a Machine's location.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

UNDER NO CIRCUMSTANCES IS IBM LIABLE FOR ANY OF THE FOLLOWING: 1) THIRD-PARTY CLAIMS AGAINST YOU FOR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE); 2) LOSS OF, OR DAMAGE TO, YOUR RECORDS OR DATA; OR 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES, LOST PROFITS OR LOST SAVINGS, EVEN IF IBM, ITS SUPPLIERS OR YOUR RESELLER IS INFORMED OF THEIR POSSIBILITY. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

Governing Law

Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Agreement, without regard to conflict of law principles.

The IBM Warranty for Machines: *The following paragraph is added to this Section:* The warranties specified in this Section are in addition to any rights you may have under the Trade Practices Act 1974 or other similar legislation and are only limited to the extent permitted by the applicable legislation.

Limitation of Liability: *The following is added to this Section:* Where IBM is in breach of a condition or warranty implied by the Trade Practices Act 1974 or other similar legislation, IBM's liability is limited to the repair or replacement of the goods or the supply of equivalent goods. Where that condition or warranty relates to right to sell, quiet possession or clear title, or the goods are of a kind ordinarily acquired for personal, domestic or household use or consumption, then none of the limitations in this paragraph apply.

The arbitrator or arbitrators designated in conformity with those rules shall have the power to rule on their own competence and on the validity of the Agreement to submit to arbitration. The arbitration award shall be final and binding for the parties without appeal and the arbitral award shall be in writing and set forth the findings of fact and the conclusions of law.

All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator.

The two arbitrators appointed by the parties shall appoint a third arbitrator before proceeding upon the reference. The third arbitrator shall act as chairman of the proceedings. Vacancies in the post of chairman shall be filled by the president of the ICC. Other vacancies shall be filled by the respective nominating party. Proceedings shall continue from the stage they were at when the vacancy occurred.

If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints its, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed.

The English language version of this Agreement prevails over any other language version.

HONG KONG AND MACAU

Governing Law: The following replaces "laws of the country in which you acquired the Machine" in the first sentence: laws of Hong Kong Special Administrative Region.

INDIA
