

Chapter 1. Product overview

This section provides the product description and installation instructions for the IBM 1X16 Tape Autoloader.

Product description

Data backup is essential to protect irreplaceable information. Backing up data to magnetic tape is an easy, cost-efficient method used by many small and medium sized businesses. However, most enterprises have so much data that a single backup tape is not enough; the information has to be spread across numerous tapes. To avoid constantly changing tapes manually, many tape backup systems include an autoloader.

An autoloader is a robot that includes a tape drive and one or more magazines of tape cartridges. The user's application can automatically load and unload tape cartridges as required for data backup or data retrieval. Autoloaders provide a compact, high capacity, but low cost method for simple, unattended data backup.


The IBM 1X16 Tape Autoloader can be purchased with either LTO (360726x) or SDLT (360716x) tape drives. Each model contains one tape drive and two eight-cartridge magazines. They include a password protected mailslot to manually insert a single cartridge. You can insert the cartridge directly to the tape drive, provided there is no tape already in the drive; or you can load the cartridge to a magazine slot provided that slot is not already occupied. Finally, the autoloader includes a barcode reader to help organize and identify your individual cartridges.

The front panel on the autoloaders include a Liquid crystal display (LCD) and four function keys. A scrolling menu on the LCD display allows you to obtain information from the autoloader or to enter commands. The front panel also includes two LEDs that indicate the autoloader's ready status and error status.

The autoloader connects to your host server via a SCSI connection allowing the host to send data and commands automatically. You can also connect to the autoloader using an Ethernet connection to perform administrative functions and download system updates.

Front view

The mailslot, liquid crystal display (LCD), function keys, status light-emitting diodes (LEDs), power switch, and left and right magazines are visible on the front panel of the autoloader.



Mailslot

The autoloader has a manual entry port or mailslot that you can use to load or unload a single cartridge. To maintain security, you can password protect the mailslot. You can insert a cartridge in the mailslot even if both magazines are completely filled, as long as the tape drive itself is empty. You can also pass a tape cartridge from the mailslot to the magazine if the tape drive is full but the magazine is not. Be sure to run an inventory from the host application after using the mailslot. The mailslot is not available from the host application.


LCD

The LCD enables you to use the scrolling menu to perform diagnostics and to enter commands.

Function keys

The function keys enable you to move through the scrolling menu to make selections. The following function keys are available:

- Enter. Press the to select an option.
- **Escape.** Press to return to the previous menu, to move backwards on a screen, or to abort an operation.
- scroll up. Press to move up through a menu or through the menu settings.
- scroll down. Press to move down through a menu or through the menu settings.




Status LEDs

The status LEDs display autoloader and drive status information. The green, Ready LED shows ready status information, and the amber, Fault LED shows fault status information. A solid Fault LED indicates an error, and a blinking Fault LED indicates a need for maintenance.

Magazines


The autoloader comes with two cartridge magazines. The magazines are removable, and each magazine accommodates up to eight cartridges. The handles on magazines are removable and enable you to configure any magazine to fit in the left or the right magazine bay.



The magazines store your data tape cartridges and can also store your cleaning cartridge. The magazines also contain the part of the robotics that moves the cartridges inside the autoloader.

Rear view

The fans and connectors are visible on the rear of the autoloader.



Cooling fans

The autoloader has a system cooling fan, and a fan to cool the power supply. These fans maintain the acceptable temperature range for the tape drive path and all internal electronics.

AC power

The autoloader requires a nominal voltage in the range of 110 V to 220 V to operate.

Ethernet connection

The autoloader's Ethernet connection enables you to connect the autoloader to a network, enabling remote administration. You can also connect the autoloader to an SNMP server and a time server. The Ethernet connection supports Hyper Text Transfer Protocol (http). You can download system updates and perform administrative tasks, including diagnostics, using http (for example a Web browser).


SCSI connection

The SCSI ID switch on the back of the drive carrier assembly (DCA) is not used and is reserved for future use.

Internal view

The figure below shows how the components of the autoloader fit together. The picker sits behind the front panel and mailslot, and can "put" and "get" cartridges from the mailslot, magazines, and tape drive. The drive carrier assembly (DCA) contains the tape drive, internal power supply, and cooling fan, and can be

removed and replaced as a single component.



Picker

The picker is the component of the autoloader that moves the cartridges from one location to another. One motor rotates the picker platform to position the picker arm in front of the drive, mailslot, or desired magazine. Another motor positions the picker arm to retrieve or replace the cartridge. The rotation motor engages the arm on a notch of the cartridge, and the translation motor moves the cartridge from the picker to the drive (or magazine or mailslot) or from the drive (or magazine or mailslot) to the picker.

Drive Carrier Assembly (DCA)

The DCA is configured with either a SDLT tape drive (360716x) or a LTO tape drive (360726x). The SDLT and LTO DCAs are **NOT** interchangeable. The DCA facilitates the easy removal of the drive. To change tape drives, you can replace the DCA without having to remove the top cover of the autoloader.

Chapter 2. Installation and configuration

This chapter describes how to rack-mount and configure the autoloader.

Preparation

Statement 4:





CAUTION:

Use safe lifting practices.

Before you install your new autoloader, unpack it carefully and inspect it for any damage that might have occurred during shipping. The Quick Start card included in the packaging will help those familiar with tape products to quickly install and use the autoloader.

Accessories

In addition to this User's Guide CD, the following accessories come with each autoloader:

- Quick Start Guide
- SCSI cable (host to library)
- SCSI terminator
- · Rack-mount hardware
- · Power cord
- Barcode labels (cleaning and data)
- Trial software CDs
- Cleaning cartridge

Tools required

You will need a #2 Phillips screwdriver to install your autoloader.

Rackmount

It takes two people to rack mount your autoloader.


Important: Review the documentation that comes with your rack enclosure for safety and cabling considerations. When installing your autoloader in a rack, the following considerations should be made:

- Extend the rack anti-tip device, if available.
- The autoloader should be installed in a maximum 35° C environment.

- To ensure proper air flow, it is recommended that air vents not be blocked, usually 15 cm (6 in.) of air space is sufficient.
- To ensure stability, precautions should be taken to prevent uneven loading of the rack. Loading of the rack should begin at the bottom.
- When multiple components are installed in a rack, precautions should be taken to prevent overloading of power outlets.
- Verify that the total current capacity of all devices in the rack does not exceed the rating of Power Distribution Unit (PDU) or power receptacle outlet.
- The autoloader should always be connected to a properly grounded outlet.
- The 360726x and 36071x autoloaders **can** be installed in IBM racks and **may** be installed in non-IBM racks depending on the actual configuration. Additional parts (not included with 360716x or 360726x) may be required for non-IBM rack installations.


How to rackmount the autoloader

1. Install two cage nuts (for Netbay standard rack) or two clip nuts (for Netbay Enterprise rack), 44.45 mm (1.75 in.) apart, onto each of the four rails of the rack, making sure you install each pair of clip nuts at exactly the same level.




2. There are two sets (different lengths) of extension brackets. Attach the autoloader brackets that best fit your application to the rear of autoloader,

tightening the fours screws until snug.



3. Attach one support bracket to each rear rail of the rack, loosely installing the screws through the clip nuts. Make sure that you attach the side of the support bracket that has only two holes, and do not tighten the screws yet.

You will tighten the screws in Step 9.




Place the autoloader into the rack and do the following:

a. With at least two persons, position the autoloader in the rack so that each autoloader bracket slides into a support bracket. Each autoloader bracket


should slide along the lip of the support bracket.




b. Slide the autoloader in place so that the front ears of the autoloader align with the front clip nuts.




5. Loosely install the four screws that connect the two support brackets to the two front rails.



6. Loosely install the four screws that connect the support brackets (two screws per support bracket) to the autoloader bracket.



- 7. Verify that the autoloader is level. Adjust as needed.
- 8. Tighten the four screws that attach the two front ears to the front rails.
- 9. Tighten the four screws that connect the two support brackets to the two autoloader brackets.
- 10. Tighten the four screws that connect the two support brackets to the two rear rails.



Attaching the SCSI cable

The SCSI connection enables the host computer to communicate with the autoloader.


Note: You must have already installed a SCSI host adapter card in the host computer. The adapter card must be LVD-compatible.

Before you start, make sure that your cable is long enough to reach from the autoloader to the host computer. Remember, your SCSI bus cannot be longer than 7.92 m (26 ft.). The autoloader's internal SCSI length is 406.4 mm (16 in.).

To make the SCSI connection do the following:

- 1. If the host computer is connected to a network, check with the system administrator before turning off power.
- 2. Properly turn off all peripheral devices connected to the host computer.
- 3. Turn off the host computer.
- 4. Install the supplied 68-pin SCSI cable to the double-stacked SCSI connector that is on the back of the autoloader/DCA and tighten the screws. You can install

the SCSI cable in either port.



- 5. Install the supplied SCSI terminator to the remaining connector that is on the autoloader/DCA and then tighten the screws.
- 6. Attach the other end of the SCSI cable to the SCSI host adapter card.
- 7. Turn on any peripheral devices that you powered off in Step 2.

Note: Do not turn the host computer back on at this time. First you must configure the autoloader.

After you have made the SCSI connection, you need to connect the autoloader's power cord and then start the autoloader (see the next section "How to power on the autoloader" on page 16).

How to power on the autoloader

Statement 1:





DANGER

Electrical current from power, telephone, and communication cables is hazardous.

To avoid a shock hazard:

- Do not connect or disconnect any cables or perform installation, maintenance, or reconfiguration of this product during an electrical storm.
- Connect all power cords to a properly wired and grounded electrical outlet.
- Connect to properly wired outlets any equipment that will be attached to this product.

- Never turn on any equipment when there is evidence of fire, water, or structural damage.
- Disconnect the attached power cords, telecommunications systems, networks, and modems before you open the device covers, unless instructed otherwise in the installation and configuration procedures.
- Connect and disconnect cables as described in the following table when installing, moving, or opening covers on this product or attached devices.

A power cord was supplied with your autoloader. Carefully inspect it and make sure that it is the correct one for your country or region. If the supplied power cord is not correct, contact your customer service representative or your point of sale person.

To connect the power cord:

Note: Make sure that the host power is turned off before powering on the autoloader.

- 1. Be sure that the power switch on the back of the autoloader is off (the 0 is pressed).
- 2. Connect the female end of the power cord to the power connector on the back of the autoloader.
- 3. Plug the male end of the power cord into the power source.

To power on the autoloader:

1. Push the power switch that is on the back of the autoloader to the on position (the 1 is pressed).

Wait while the autoloader performs its power-on sequence. During this time, the following activities occur:

- The IBM logo displays.
- The left (green) and right (amber) LEDs flash back and forth during power-on self-test (POST).
- The autoloader performs a calibration and magazine element status. The Ready LED flashes green.

Once the power-on sequence completes and the autoloader is ready, the Ready LED is steady green.

Note: When the autoloader is idle for awhile, the IBM logo displays and the LCD backlight turns off (into power-save mode).

Note: After you power on the autoloader, you can use the switch on the front to power on or off the autoloader and to place it in standby.

- 2. When you first power on the autoloader, it automatically runs a POST. During the POST, the left (green) and right (amber) LED flash alternately back and forth. After the POST, but during calibration, the left (green) LED flashes. Do one of the following:
 - If the left (green) LED is on steady, indicating that the autoloader powers on successfully, continue configuring the autoloader.
 - If the autoloader does not power on at all, or if the right (amber) LED is lit on flashing, ensure the following:
 - The power switch is on.
 - The power cord is inserted correctly.
 - The SCSI chain is terminated.
 - The SCSI cable is connected to the autoloader and to the host computer.
 - An error code does not appear on the autoloader's LCD. If an appears, see Appendix A, "Troubleshooting", on page 61 for more information.

When you first power on the autoloader, the default method for setting the IP address is the dynamic method (DHCP). If you want to use DHCP you can skip this step. To determine the IP address when using DHCP, view the Ethernet status information (see "Viewing Ethernet information" on page 42").

Statement 5:





CAUTION:

The power control button on the device and the power switch on the power supply do not turn off the electrical current supplied to the device. The device also might have more than one power cord. To remove all electrical current from the device, ensure that all power cords are disconnected from the power source.



To power off the autoloader:

- a. Press the power switch on the front panel for approximately five seconds.
- b. When the LCD screen goes blank, push the power switch on the back of the autoloader to the OFF position (the 0 is pressed).

Installing the software

Your autoloader includes trial version backup CDs. These CDs contain popular backup and restore applications for Microsoft® Windows® 2000 Professional, Microsoft Windows NT®, Netware, and Linux. You can install the application you choose for your computer by following the installation instructions that come with the CD. However, these trial versions expire 30 to 60 days, depending on the application.

You should use the trial period to determine the best application for your specific computer configuration. For information on purchasing a permanent upgrade license, go to http://www.pc.ibm.com/ww/eserver/xseries/tape.html, or follow the instructions from the CD. Not all of the applications on the trial CD's are supported by the IBM autoloader. Please go to

http://www.pc.ibm.com/us/compat, click Tape Backup Units, then search for either 360716X or 360726x to see the current support list.

You can also use this autoloader directly from the Windows 2000 native backup applets.

Windows 2000 driver instructions

- 1. Right click on **My Computer** on the desktop.
- 2. Click Manager.
- 3. Click Device Manager.
- 4. Click **Tape to expand**.
- 5. Right click Quantum SCSI Sequential Device or the device name.
- 6. Click Properties.
- 7. Click **Driver**.
- 8. Click **Update driver**.
- 9. Click Next.
- 10. Click Search (recommended), then click Next.
- 11. Select **Specify a location**, (A:\, D:\) depending on the media type, then click Next.
- 12. Browse the media type (CD or Floppy) and select Win-2000 Folder.


- Select the Driver folder for the tape drive and the Autoloader folder for Robotics.
- 14. Select the Driver .INF file.
- 15. Select **Open** then **OK** for the updated driver.
- 16. Reboot the system.

Note: Repeat the steps above for the tape drive drivers.

Configuration

To configure your autoloader, start with the main menu on the front panel. (If the main menu is not already visible on the LCD, press Enter.)

The Configuration submenu has the following options:



To configure the autoloader, you must set the following:

- SCSI ID
- Ethernet IP address (if you are not using DCHP)
- SNMP server IP address
- Time server IP address (or the time zone, date, and time, if configuring manually)
- Control mode
- · Security option

Setting the SCSI ID

Each SCSI device attached to a server or workstation must have a unique SCSI ID. For DLT/SDLT models, you need one SCSI ID for the autoloader. For LTO models, you need to set up separate SCSI IDs for the tape drive and the autoloader.

Check the IDs on all other SCSI devices that are on the SCSI bus, including the SCSI host adapter, and select unused SCSI IDs for the autoloader robotics (all models) and drive (LTO only). The factory default SCSI IDs for the autoloader's robotics and LTO drive are 04 and 05 respectively, but you can select any unused number between 00 and 15. If the autoloader factory default SCSI IDs are being used by other devices on the SCSI bus, you need to change these SCSI IDs to avoid conflicts.

To set the SCSI ID:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter.)
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to SCSI ID.
- 4. Press Enter.
- 5. Scroll to the number that you want to set as the autoloader's SCSI ID.
- Press Enter.
 - Cycle Power for new SCSI ID is displayed on the LCD.
- 7. To shut down the autoloader, press and hold the power button on the front panel until Power Off displays on the LCD.
- 8. Press the power button again to power on the autoloader. The new SCSI ID is now in effect.

Setting the Ethernet connection

Ethernet is the method that the autoloader uses to access a network. With an Ethernet connection, you can remotely access the autoloader over the network to which it is connected. To use the Ethernet connection, you must define the following:

- A dynamic or static IP address for the autoloader (Required)
- A subnet mask (Required)
- An IP gateway (Optional)
- A Simple Network Management Protocol (SNMP) server (Optional)
- A time server, or set the time and time zone manually (Optional)

IP address

An Internet Protocol (IP) address is the address of any device that is attached to a network. Each device must have a unique IP address. IP addresses are written as four sets of numbers separated by periods ranging from 0.0.0.0 to 255.255.255.255.

IP addresses are permanent or dynamically assigned. A permanent, or static, address remains the same each time the device connects to a network. A dynamic address changes each time the device connects to the network, and is assigned by the network server using a class of software called Dynamic Host Configuration Protocol (DHCP).

To set a dynamic IP address:

1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter.)

- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Ethernet.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to Set IP.
- 6. Press Enter.
- 7. Scroll to Dynamic (DHCP).
- 8. Press Enter. Please Cycle Power to use DHCP displays on the LCD.
- 9. Press and hold the power button on the front panel until System Shutdown Please Wait displays on the LCD. Power off displays on the LCD, then the autoloader shuts off.
 - Power Off displays on the LCD, then the autoloader shuts off.
- 10. Press the power button again to power on the autoloader. The IP address is now set by the DHCP server.

To set a static IP address:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Ethernet.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to Set IP.
- 6. Press Enter.
- 7. Scroll to Static IP and press Enter.
- 8. At each position of the IP address, use the up and down arrows to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit that you want to change.

When you have advanced through all of the digits of the IP address, the autoloader displays Enter to save.

9. Press Enter.

The Configuration submenu reappears and the static IP is now in effect. You do not need to restart the autoloader.

10. Press the Escape or Enter button to return to the Ethernet submenu.

Subnet Mask

Creating a subnet mask is a method to split IP networks into a series of subgroups, or subnets, to improve performance and security.

To set a subnet mask:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Ethernet.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to Set Subnet Mask.
- 6. Press Enter. The cursor automatically displays at the first digit.
- 7. At each position of the mask address, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

When you have advanced through all of the digits of the mask address, the autoloader displays Enter to save.

- 8. Press Enter.
- 9. Press the Escape or Enter button to return to the Ethernet submenu.

IP Gateway

An IP gateway is a device that converts data into the IP protocol.

To set an IP gateway:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Ethernet.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to Set Gateway.
- 6. Press Enter. The cursor automatically displays at the first digit.
- 7. At each position of the gateway address, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

- 8. Press Enter. GW changed displays on the display. You do not need to restart the autoloader.
- 9. Press the Escape or Enter button to return to the menu.

Setting the SNMP server

An SNMP server monitors a network by processing reporting activity in each network device (hub, router, bridge, etc.). The server uses this information to define what is obtainable from each device and what can be controlled.

To set an SNMP server:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Ethernet.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to Set SNMP Server.
- 6. Press Enter. The cursor automatically displays at the first digit.
- 7. At each position of the SNMP server address, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

When you have set the SNMP server address, the autoloader displays Enter to

8. Press Enter. SNMP Server changed to displays on the LCD. You do not need to restart the autoloader.

9. Press Escape or Enter to return to the Ethernet submenu.

Setting the time server

If you locate a time server that is compatible with SNTP, you can connect the autoloader to a server that will supply the correct date and time. The autoloader uses this information to time stamp information in its memory and to initiate autocleaning.

To set a time server:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Ethernet.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to **Set Time Server**.
- 6. Press Enter. The cursor automatically displays at the first digit.
- 7. At each position of the time server address, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

When you have set the time server address, the autoloader displays Enter to save.

- 8. Press Enter. Time Server changed to appears on the panel display. You do not need to restart the autoloader.
- 9. Press Escape or Enter to return to the Ethernet Submenu.

Setting the time

Both the front panel and the Web Administration display time stamp information. If you are connected to a time server, the time stamp information displays as regular time (Month/Date/Year Time).

If you are not connected to a time server, the time stamp information displays as Power On Cycles (POC), Power On Hours (POH). POC (5-digit number) is the number of times the system has booted since it was manufactured. POH is the number of hours, minutes, and seconds since the current boot occurred.

For example, POC: 00121, POH: 00000:00:10

If you cannot connect the autoloader to a time server for security reasons, you can set the time manually. If you want to include time changes such as daylight savings time, you must make those changes manually as well.

Note: You must reset the time after each restart unless you are connected to a time server. If you are not connected to a time server and you lose power or power off, you lose your time setting. However, your Greenwich Mean Time (GMT) setting is preserved.

To set the time zone:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.

- 3. On the Configuration submenu, scroll to Time.
- Press Enter.
- 5. On the Ethernet submenu, scroll to Set Time zone.
- 6. Press Enter. The time zone screen displays enabling you to set the hours.
- 7. Scroll to set the number of hours' difference between your local time and GMT. If you do not know the difference between your local time and GMT, refer to Appendix B, "Time Zones."
- 8. Press Enter. A new time zone screen displays, enabling you to set the minutes.
- 9. Scroll to set the number of minutes' difference between your local time and GMT.
- 10. Press Enter. The new time zone is set.

To set the date and time:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Time.
- 4. Press Enter.
- 5. On the Ethernet submenu, scroll to Set Date/Time.
- 6. Press Enter. The Date/Time screen displays, with the cursor under the first digit in the second row.
- 7. The first four digits represent the current year. At each position of the year, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

8. The next two digits represent the current month. At each position of the down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

9. The next two digits represent the current day. At each position of the day, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

10. The next two digits represent the current hour. At each position of the hour, use the up and down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

11. The last two digits represent the current minute. At each position of the down arrow to change the value of each digit. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

- 12. Enter to save displays on the LCD.
- 13. Press Enter.

Setting the change mode

You can set the autoloader to either Mixed, Random or Sequential. The default control mode is Random.

In Mixed mode, the autoloader allows both Sequential and Random modes of operation. Any Random Access command, such as MOVE MEDIUM, functions as long as the command is correct for the current state. Any SCSI unload operation to the drive causes the autoloader to automatically cycle to the next available piece of media. It is like an autodetect based on commands from the host.

In Random control mode, you (or the backup software) can specify which cartridge you want to use and where you want it to go. You will probably use this mode the most.

The Sequential control mode supports certain backup applications that do backup, when one cartridge is read or written to the end of the tape, the autoloader automatically returns that cartridge to its slot and loads the cartridge from the next higher numbered slot to the tape drive to be read or written to. This continues until the backup software stops accessing the drive or until all the cartridges have been sequentially accessed. The autoloader does not move the media until the host requests the tape drive to unload the tape.

In Seq Cycle Mode, which is an option of Sequential mode, the autoloader automatically starts over with magazine slot 1 when the last cartridge is used (slot 16 or highest filled slot). If this control mode is not set, the autoloader stops when the last cartridge available has been used. In Seq Cycle Mode, the autoloader continues to cycle until a user stops it.

Setting the Change mode

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Change Mode.
- 4. Press Enter. The mode options appear. A check mark appears after the enabled mode.
- 5. Do one of the following:
 - To leave the control mode unchanged, press Escape.
 - To change the control mode, scroll to the mode to which you want to set the autoloader and press Enter. Restart to enable new mode appears on the LCD.
 - a. Press and hold the power button on the front panel until System Shutdown Please Wait displays on the LCD. Then Power Off appears on the LCD, and the autoloader shuts off.
 - b. Press the power button again to power up the autoloader. The new control mode is now in effect.

Note: When you enable the Sequential mode, LUN 1 no longer appears on the SCSI bus; only the tape drive appears.

Sequential control mode operation

If you enable the Sequential control mode, you must use the Sequential Ops submenu under the Commands menu to operate the autoloader after you restart the autoloader. The Start command allows you to load the first cartridge. The Resume command enables you to continue from the last-used slot, if a user stopped the cycle. The Stop command allows you to stop the cycle.

To start Sequential control mode operation:

- 1. On the main menu, scroll to Commands. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Sequential Ops.
- 4. Press Enter.
- 5. On the Sequential Ops submenu, scroll to Start.
- 6. Press Enter. Moving first tape to drive displays on the LCD.

To stop Sequential control mode operation:

- 1. On the main menu, scroll to Commands. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Sequential Ops.
- 4. Press Enter.
- 5. On the Sequential Ops submenu, scroll to Stop.
- 6. Press Enter. Ejecting tape from drive displays on the LCD.

To resume Sequential control mode operation:

- 1. On the main menu, scroll to Commands. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Sequential Ops.
- 4. Press Enter.
- 5. On the Sequential Ops submenu, scroll to Resume.
- 6. Press Enter. Moving next tape to drive displays on the LCD.

How to set Security

You can add security to the front panel by password-protecting the autoloader's functionality. The security only protects the front panel functionality. The default security setting is Off, meaning that no password is required. However, you can enable the security option so that users must enter a password to access functionality.

Security option

When you first power on the autoloader, the security option is set to Off. Use the following procedure to enable the security option. You must have an administrator-level password to set passwords.

To set the security option:

- 1. On the main menu, scroll to Configuration. (If the main menu is not already visible on the LCD, press Enter).
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Security.

- 4. Press Enter.
- 5. On the Security submenu, scroll to Security. If a checkmark appears after the word, the security option is on. If no checkmark appears, the security option is off.
- 6. To change the setting, press Enter. This toggles the security option and off.

Passwords

Many operations on the autoloader are password-protected to ensure data integrity. You can set passwords at the administrator level and at the operator level. Operator-level users have access to the Commands and Status menus. Administrator-level users have access to all functionality.

Passwords must be exactly six numbers long. The default password is 000000.

To set a password:

- 1. On the main menu, scroll to Configuration.
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Security.
- 4. Press Enter.
- 5. On the Security submenu, scroll to Set Password.
- 6. Press Enter.
- 7. To set a password at the operator level, scroll to Operator. To set a password at the administrator level, scroll to Administrator.
- 8. Press Enter. The Set Password screen appears.
- 9. Press Enter. If you are not logged in as Administrator, press Enter again to log in. A textbox appears above the first asterisk.
- 10. In the textbox, scroll to the first character of the password. The cursor automatically appears at the first number of the password.
- 11. At each position of the password, use the up and down arrow to change the value of each number. Press Enter to advance your cursor to the next number.
 - **Note:** If you make a mistake, you can press Escape to backspace to the digit you want to change.
- 12. Press Enter. The textbox above the asterisk disappears and another textbox appears above the next asterisk.
- 13. Repeat steps 11 and 12 to enter the remaining digits of the password.

Note: Press Escape to backspace to a previous textbox, if necessary.

- When you have entered six numbers, the autoloader displays Submit Passoword below the asterisks.
- 14. Press Enter to submit the password. Password Successfully Changed displays on the LCD.
- 15. Press Enter. The Operator and Administrator options reappear. You can enter another password or press Escape or Enter to return to the main menu.

Chapter 3. Using the autoloader

This chapter describes how to use the autoloader. You can use the autoloader by any of the following methods:

- · Autoloader's front panel
- Ethernet Web Administration
- Host backup software

The front panel is located on the front of the autoloader and must be operated manually.


The Ethernet connection allows you to perform administrative functions remotely using Web Administration.

Both the front panel and Web Administration display time stamp information. If you are connected to a time server, the time stamp information appears as calendar/date time (Month/Date/Year Time).


If you are not connected to a time server, the time stamp information appears as Power On Cycles (POC), Power On Hours (POH). POC (5-digit number) is the number of times the system has booted since it was manufactured. POH is the number of hours, minutes, and seconds since the current boot occurred.

Front Panel components

The front panel includes a blue backlit LCD, four function keys (scroll up, scroll down, Enter and Escape), and two LED's.

Function keys

Use the function keys to navigate through the menu and select options. Use the up and down scroll buttons to position the cursor next to the item you want. Once the cursor is in place, press Enter to select the item. To return to a previous menu without making a selection, use the Escape button. The Escape button can also function as a backspace key.

LEDs

The LEDs display autoloader and drive status information. When the autoloader is powered on, the left, green LED provides ready status information, and the right, amber LED provides fault status information.

Table 1. Indicator Activity

Indicator	State	Operating Condition
Left (green)	On	Autoloader and tape drive are idle.
	Slow flash	Tape drive only is active.
	Fast flash	Autoloader only is active or Autoloader and tape drive are active.

LCD

The LCD displays a scrolling menu that allows you to access information and execute commands.

Note: When the autoloader is idle for a few minutes, the logo screen displays on the LCD, similar to the screensaver function on your computer. Press any function key to launch the top-level menu.

The four menus displayed on the LCD are circular menus. That is, you can scroll through the options using either the up or down scroll buttons.

Front Panel functionality

Note: If you try to execute a command without entering a password, the autoloader displays the Enter Password screen until you enter a password. After you enter a password, the autoloader takes you back to the command screen that you were at before entering the password.

You can perform the following functions through the front panel.

Entering passwords

Many functions on the autoloader might be password protected to ensure data integrity. To access the menu items necessary to execute these functions, you must first enter your password. All passwords are six numeric digits long.

To enter a password:

Security must be turned on before you can enter a password. See "How to set Security" on page 26 for more information about security options.

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Enter Password.
- 4. Press Enter.
- 5. On the Enter Password submenu, scroll to:
 - · Operator to enter an operator-level password.
 - Administrator to enter an administrator-level password.
- 6. Press Enter.

The Login screen appears with a row of asterisks. A textbox appears above the first asterisk.

7. In the textbox, scroll to the first number of the password. The cursor automatically appears at the first character of the password.

* * * *

8. At each position of the password, use the up and down arrow to change the value of each number. Press Enter to advance your cursor to the next digit.

Note: If you make a mistake, you can press Escape to backspace to the digit you want to change.

9. Press Enter.

The textbox above the asterisk disappears and another textbox appears above the next asterisk.

- 10. Repeat steps 8 and 9 to enter the remaining digits of your password. When you have finished entering your password, the LCD displays Submit Password below the asterisks.
- 11. Press Enter to submit your password. You return to the Enter Password submenu. (If you submitted an incorrect password, Incorrect appears on the LCD and the row of asterisks reappears so that you can re-enter the password.)

When you enter a password, all password-protected functionality is available until you log out. See the "Logout" section below for information about how to log out. If you do not use the front panel for a period of time, the logo reappears on the LCD. When the logo reappears, the autoloader has automatically logged you out. You will have to re-enter your password again to access the menu functionality.

Logging out

To log out do the following:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Log Out.

Note: You can also press Escape (back up until the logo appears) to log out.

Setting the Change Mode

To change the control mode, see "Setting the Change Mode".

Using data cartridges

The 360716x autoloader will recognize DLT IV or SDLT media cartridges. The 360726x autoloader will recognize LTO media cartridges. If you try to load an incompatible tape, the fault status LED will show solid yellow and the LCD will display an error message.

Typically, when you first install your autoloader, you load your cartridges into the magazines and then load the magazines into the autoloader. However, you can insert and eject cartridges individually using the mailslot, or you can eject a magazine, manually load and unload cartridges, then load the magazine back into the autoloader. The autoloader automatically detects the presence of a cartridge in the magazine slot.

Note: On the front panel menu, whenever you see Enter or Eject, it means the tape enters and leaves the autoloader through the mailslot. Whenever you see Load or Unload, it means the tape is loaded into or unloaded from the tape drive.

If you try to perform an illegal operation, the autoloader refuses to perform the operation. For example, if you try to load a cartridge through the mailslot to the drive but the drive already contains a cartridge, the mailslot does not unlock. If you try to unload a cartridge from the drive while the autoloader is writing to the tape, your command is ignored.


Inserting a Single Cartridge

Security option is turned on, you have to enter a valid password to unlock the mailslot before you can load a cartridge. When you insert a cartridge through the mailslot, you can load it into the tape drive or store it in a magazine.

To insert a cartridge to the tape drive:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Enter.
- 4. Press Enter. On the Enter submenu, scroll to To Drive.
- 5. Press Enter. After Load cartridge appears on the LCD, a countdown appears. You have 20 seconds to load a cartridge through the mailslot before it re-locks.

Note: Push in the cartridge until you meet resistance. The cartridge will be about two inches (5.0 cm) inside the mailslot, and only the end of the cartridge will be visible through the mailslot door.



- 6. Once you have inserted the cartridge, the prompt Enter to Continue appears. You have five seconds to respond.
- 7. Press Enter.

Note: If the insert cartridge function fails, the cartridge ejects and you will have to perform steps 5 through 7 again.

To insert a cartridge to a magazine slot:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Enter.
- 4. Press Enter. On the Enter submenu, scroll to To Location.
- 5. Press Enter.

A map of all the magazine slots appears. Slots that are occupied by a data cartridge are indicated by an asterisk (*). The slot that is assigned to a cleaning tape is indicated with an exclamation point (!). The slot that is occupied by a cleaning tape is indicated with an @.

- 6. Scroll to the slot where you want to store the cartridge.
- 7. Press Enter. After Load cartridge appears on the LCD, a countdown appears. You have 20 seconds to load a cartridge through the mailslot before it re-locks. The autoloader automatically loads the cartridge into the selected slot.

Note: If the load cartridge function fails, the cartridge steps 4 through 7 again.

Moving a single cartridge

You can easily move a single cartridge from one location to another inside the autoloader.

To move a single cartridge:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Move.
- 4. Press Enter. The Move screen appears Under From:, scroll to the current location of the cartridge you want to move. Slots that are occupied by a data cartridge are indicated by an asterisk (*).
- 5. Press Enter.
- 6. Under To: scroll to the location to which you want to move the cartridge. Slots that are occupied by a data cartridge are indicated by an asterisk (*).
- 7. Press Enter. The LCD displays Ent or Esc below your selections.
- 8. Press Enter.

An hourglass appears on the LCD as the autoloader moves the cartridge to its new location. If you select an empty location, No Source Element appears on the LCD. Choose a different location.

If you select a location that is already occupied, Destination Full appears on the LCD. Choose a different location.

Ejecting a single cartridge

When you want to remove a single cartridge from the autoloader, you can specify the cartridge you want by barcode or location, or select the cartridge currently in the tape drive.

To eject a cartridge by barcode:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Eject.
- 4. Press Enter.
- 5. On the Eject submenu, choose where you want the cartridge ejected to.
- 6. Press Enter.
- 7. Scroll to By Barcode. A barcode label appears.
- 8. Scroll to the label that corresponds to the cartridge you want to unload.
- 9. Press Enter. An hourglass appears on the LCD as the cartridge you want is ejected from the mailslot. Wait until the hourglass disappears from the LCD before pulling out the cartridge.

To eject a cartridge by location:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Eject.

- 4. Press Enter.
- 5. On the Eject submenu, choose where you want the cartridge ejected to.
- 6. Press Enter.
- 7. Scroll to By Location.

A map of all the magazine slots appears. Slots that are occupied by a data cartridge are indicated by an asterisk (*). The slot that is assigned to a cleaning tape is indicated with an exclamation point (!). The slot that is occupied by a cleaning tape is indicated with an @. Scroll to the slot containing the cartridge you want to eject.

8. Press Enter. An hourglass appears on the LCD as the cartridge you want is ejected from the mailslot. Wait until the hourglass disappears from the LCD before pulling out the cartridge.

To eject a cartridge from the tape drive:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Eject.
- 4. Press Enter.
- 5. On the Eject submenu, choose where you want the cartridge ejected to.
- 6. Press Enter.
- 7. Scroll to From Drive.
- 8. Press Enter. An hourglass appears on the LCD as the cartridge you want is ejected from the mailslot. Wait until the hourglass disappears from the LCD before pulling out the cartridge.

Ejecting a magazine

When you want to remove several cartridges at once, eject the magazine(s) first.

To eject a magazine:

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Commands submenu, scroll to Eject.
- 4. Press Enter.
- 5. On the Eject submenu, scroll to Right Magazine or Left Magazine.
- 6. Press Enter. You will hear a distinctive popping sound as the appropriate magazine is ejected from the autoloader. Left magazine has been ejected or Right magazine has been ejected appears on the LCD.

Attention:

To prevent damage to the autoloader or the magazine, use both hands when removing the magazine from the autoloader, supporting the entire length of the magazine.


7. Grasp the magazine by the handle with one hand and slide it out, supporting it underneath with the other hand.

Note: Once you eject a magazine, you must fully remove it or fully re-install it before powering off the autoloader.


Installing a magazine

To install a magazine, do the following:

- 1. Grasp the magazine by the handle with one hand and support it underneath with the other hand.
- 2. Slide the magazine into the magazine bay until clicks. Make sure that you position the magazine correctly; it should slide smoothly. If you meet resistance, verify the orientation of the magazine.



The magazine is correctly installed when you feel it click into place and the front is flush with the front panel. Left Mag Inserted or Right Mag Inserted appears on the LCD. The autoloader automatically runs an inventory.



Manually operate the magazine

To load cartridges from a fully ejected magazine do the following:


There are two handles located on both ends of the magazine. You can move the slots within the magazine by using these two handles. You can use the two openings along the top of the magazine and the four openings along the bottom of the magazine to load and unload cartridges from the eight slots within each magazine.

- 1. To load cartridges in the magazine, center a slot within one of the six openings located on the side of the magazine.
- 2. Properly orient the cartridge.

Note: There is a keying feature in each slot that only allows you to fully insert the cartridge one way.

3. Fully insert the cartridge into the slot. When pushing the cartridge into the slot, you will feel a small resistance until the cartridge is properly latched into the

slot. All forward progress stops when the cartridge is fully inserted.



Note: It is fastest to load the cartridges when the magazine is fully removed from the autoloader using the four lower openings. When all four are loaded then rotate the next 4 empty slots into position for loading the next four cartridges.


To unload cartridges from a fully ejected magazine

You can remove a cartridge in the same manner as you insert it. Use the handles to center the desired slot(s) in the openings on the side of the magazine. Using your thumb and index finger, pull out the cartridge. You will feel a small resistance but continue to pull the cartridge until it frees.

How to load and unload cartridges from a partially ejected magazine

You can conveniently load and unload a cartridge from the magazine without fully removing the magazine.

1. Pull the ejected magazine until the large upper slot is accessible.




2. Rotate the desired slot into position (centered in the opening). Either load or unload a cartridge to that location. Do not expose more than the large upper opening when manually operating the magazine.

Attention:

When manually operating the left magazine, do not manually operate the magazine when it is positioned between the two marks on the top cover. Manually operating the magazine in this location can cause damage to the

autoloader and magazine.




To identify a slot

Each slot has an identification mark that is exposed when the slots are on the upper section of the magazine. You can see the identification mark on the top side of the magazine.

Each slot has a unique identification number that corresponds to the side on which the magazine is operating. If the magazine is operating on the left side, the slots are numbered L1 through L8. If the magazine is operating on the right side, the

slots are numbered R9 through R16.



Viewing status information

From the scrolling menu, you can view the following information:

- · Autoloader status
- Firmware version
- · Element status
- Tape drive status
- Tape drive version
- Ethernet information

Viewing autoloader status

The autoloader status provides information about the following:

- · Whether a magazine is installed or not
- SCSI connection status
- Ethernet connection status
- · Whether a barcode reader is installed or not

To view the autoloader status:

- 1. On the main menu, scroll to Status.
- 2. Press Enter.
- 3. On the Status submenu, scroll to Autoloader Info.
- 4. Press Enter.

5. On the Autoloader Info submenu, scroll to Status.

6. Press Enter. A list of messages similar to the following screen appears.

Magazines: L=* R=*

Loader: ONLINE

Drive: ONLINE

Mode: Random

Barcode Reader: *

Table 2. Magazines

L=* The left magazine is present. R=* The right magazine is present.

Loader

ONLINE The autoloader is available for use.

Mixed The control mode is set to Mixed.

Sequential The control mode is set to Sequential.

Barcode Reader

A barcode reader is present.

Viewing tape drive status

To view the tape drive status do the following:

- 1. On the main menu, scroll to Status.
- 2. Press Enter.
- 3. On the Status submenu, scroll to Drive Info.
- 4. Press Enter.
- 5. On the Drive Info submenu, scroll to Status.
- 6. Press Enter. A list of messages similar to the following screen appears.

- 6. Press Enter. A list of messages similar to the following screen appears

Run inventory

The autoloader automatically runs an inventory whenever you power it back on or insert a magazine. If you need to run an inventory in addition to this, you can do so manually.

Note: You cannot run an inventory if the picker contains a cartridge.

How to take inventory

- 1. On the main menu, scroll to Commands.
- 2. Press Enter.
- 3. On the Command submenu, scroll to Inventory.
- 4. Press Enter. The autoloader scans the barcodes on all the cartridges present.

Setting data compression

You can set the autoloader to write data to the tape in its native (uncompressed) format, or to compress it. Compressing the data means that the autoloader can write twice as much data to the same amount of tape. Compression also increases the performance of the data transfers from or to the SCSI bus. Typically you will want to leave this option enabled.

Note: If the data that you are writing to tape is already compressed, the compression option will expand the data rather than compress it.

To set compression option:

- 1. On the main menu, scroll to Configuration.
- 2. Press Enter.
- 3. On the Configuration submenu, scroll to Compression.
- 4. Press Enter.

If a check appears next to Compression, the compression option is enabled. If no checkmark appears, the compression option is disabled.

Updating firmware

It is very important to keep your autoloader at the latest firmware. To update your firmware, periodically visit http://www.ibm.com/support, search on'Tapetool' and follow the instructions on the Tapetool page or use the Web Administration feature to load the new firmware directly see "Web Administration functionality".

Web Administration functionality

Your autoloader's firmware includes an Ethernet interface to allow remote administration of the autoloader. The interface, called Web Administration, includes a Web server that provides a hypertext markup language (HTML)-based graphical user interface (GUI) designed for ease of use.

Many of the operations that you can perform from the front panel you can also perform remotely using Web Administration.

Open Web Administration

Web Administration has an HTML interface, which means you use a browser to open it. You must have Internet Explorer 4.0 or higher, or Netscape 4.0 or higher. You need an operator password to execute commands from the Commands page, and you need an administrator password to update the Configurations, Diagnostics, and Updates pages.

To configure either Microsoft Internet Explorer or Netscape browser settings, do the following:

For Internet Explorer 6.0:

- 1. Select Tools>Internet Options>General.
- 2. Be sure that all boxes under **Accessibility** are unchecked.
- 3. Under Temporary Internet Files→Settings, select Automatically or Every visit to the page.
- 4. Select Tools→Internet Options→Advanced. Be sure that Always send URLs as UTF-8 is not selected.

For Netscape Communicator 4.79:

- 1. Select Edit-Preferences-Advanced. Be sure that Automatically Load Images, Enable Java, Enable JavaScript, Enable JavaScript for Mail and News, and Enable Style Sheets are all checked.
- 2. Select Edit→Preferences→Advanced→Cache.
- 3. Select Every Time.

For Netscape Navigator 6.2.1:

- 1. Select Edit>Preferences>Privacy & Security. Be sure that Accept all images.
- Select Edit>Preferences>Advanced. Be sure Enable Java, Enable JavaScript, Enable JavaScript for Mail and Newsgroups, and Enable Style Sheets are all checked.
- 3. Select Edit→Preferences→Advanced→Cache.
- 4. Select Every Time I View the Page.

To open the Web administration tool, do the following:

- 1. On your computer, open your browser.
- 2. In the browser's address field, enter the IP address for your autoloader. (For information on determining the IP address for your autoloader, see "Setting the Ethernet connection" on page 20. The home page appears in your browser window.

When you access Web Administration, the home page looks like this:

Status information

Status information appears on the right-hand side of the home page and every page of Web Administration except the Updates page. The status information is updated automatically every 60 seconds. So changes to the status appear in the status window update, but might take approximately 60 seconds to refresh. You can also click Status to get an immediate update on status information.

The menu headings also appear at the top of every page. To access the functionality under the menu heading, click the menu heading. The first time that you connect, Web Administration prompts you for your username and password, then it displays the opening page for that menu.

Time display

If you are connected to a time server, the time stamp information appears as calendar/date time (Month/Date/Year Time).

Power On Cycles (POC), Power On Hours (POH) where POC (5-digit number) is the number of times the system has booted since it was manufactured.


POH is the number of hours, minutes, and seconds that the system has been on since the current boot occurred.

Feedback on pages

If there is feedback when you submit a request, the feedback appears to the left of the submit button.

Commands page

You can move tapes, run a system inventory, reset the picker to its home position, or set sequential operations from the Commands page. When you click Commands, a page similar to the following appears:



Moving tapes

From a remote location, you can request that a tape be moved from one position to another.

To move a tape:

- 1. On any Web Administration page, click Commands.
- 2. From the drop-down menu under From:, select the current location of the tape that you want to move.

Note: You can also click the slot on the graphic to select it.

- 3. From the drop-down menu under To:, select the location to which you want to move the tape.
- 4. Click submit.

Run inventory

The autoloader automatically runs an inventory whenever you power it on or insert a magazine. If you need to run an inventory in addition to this, you can use Web Administration to do it remotely.

To run an inventory:

- 1. On any Web Administration page, click Commands.
- 2. On the Commands page, click Inventory.

Set to home

If the autoloader is not able to successfully execute a move or inventory command, try executing a Home command and then retry the move or inventory command again.

The Home command resets the autoloader as a means to help the autoloader recover from an unexpected internal condition.

To set to Home:

- 1. On any Web Administration page, click Commands.
- 2. On the Commands page, click Home.

Set sequential operations

The Sequential operations mode supports certain backup applications that do not manage media. During backup, when one cartridge is read or written to the end of the tape, the autoloader automatically returns that cartridge to its slot and loads the cartridge from the next higher numbered slot to the tape drive to be read or written to. This continues until the backup software stops accessing the drive or until all the cartridges have been sequentially accessed. The autoloader does not move the media until the host requests the tape drive to unload.


To start Sequential operations, click Start.

To stop Sequential operations, click **Stop.**

To stop Sequential operations, click Resume.

Configurations page

The Configurations page includes a submenu on the left-hand side of the page. When you click Configurations, a page similar to the following appears:



Set System Operations options

How to change the SCSI ID

You can change the autoloader's SCSI ID from Web Administration.

How to change the SCSI ID: On any Web Administration page, click **Configurations.**

- 1. From the drop-down list under SCSI ID, click the number to which you want to set the ID.
- 2. Click **submit**. You must perform a system reset before the new SCSI ID takes effect, or you can use the front panel to power cycle your machine.

Set the compression

To set the compression do the following

- 1. On any Web Administration page, click **Configurations.**If a checkmark appears in the box next to Compression, compression is enabled. To disable compression, click the box to remove the checkmark. If no checkmark appears in the box next to Compression, compression is disabled. To enable compression, click the box to enter a checkmark.
- 2. Click submit.

Set the cleaning mode

To enable the Auto Clean function, you must have a slot designated for the cleaning tape cartridge. If you or another user have already designated a slot, that slot's number appears next to Cleaning Cartridge Location. If a slot has not been designated, the box displays None.

Note: For optimal performance, leave autoclean set at disabled. It is better to let your application software handle the cleaning.

How to set the cleaning tape slot:

- 1. On any Web Administration page, click Configurations.
- 2. From the drop-down list next to Cleaning Tape Location, select the number of the slot in which you want to store the cleaning cartridge, or select None if no cleaning cartridge is desired.
- 3. Click **submit**.To clean the tape drive manually, use the Move function to load and unload the cleaning tape from the tape drive. If you want to set the Auto Clean option, use the following procedure.

How to set auto clean:

- 1. On any Web Administration page, click Configurations.
- 2. If a checkmark appears in the box next to Enable Auto Clean, the option is enabled. To disable Auto Clean, click the box to remove the checkmark. If no checkmark appears in the box next to Enable Auto Clean, the option is disabled. To enable Auto Clean, click the box to enter a check-mark.
- 3. Click submit.

Set the system time

Both the front panel and Web Administration display time stamp information. If you are connected to a time server, the time stamp information appears as calendar/date time (Month/Date/Year Time).

If you are not connected to a time server and you do not manually set the time through the front panel or via the Web Administration, the time stamp information appears as Power On Cycles (POC), Power On Hours (POH). POC (5-digit number) is the number of times the system has booted since it was manufactured. POH is the number of hours, minutes, and seconds since the current boot occurred.

Note: You only need to set the time zone if you are using a time server.

Note: The time zone does not reset when power cycled.

To set the time zone:

- 1. On any Web Administration page, click **Configurations**.
- 2. From the first drop-down list next to Time Zone, select the number of hours' difference between your local time and Greenwich Mean Time (GMT). For example, if you live in Colorado, the time difference is 6 hours. See Appendix B, "Time Zones" for a list of times and time zones.
- 3. From the second drop-down list next to Time Zone, select the number of minutes' difference between your local time and Greenwich Mean Time (GMT).
- 4. From the month drop-down list, select the current month.
- 5. From the day drop-down list, select the current day.
- 6. From the year drop-down list, select the current year.
- 7. In the hour textbox, type the current hour, in 24-hour format.
- 8. In the minute textbox, type the current minute.
- 9. Click submit.

Set Networking Options

When you originally installed the autoloader, you set the Ethernet configurations through the front panel. However, you can change them through the Web Administration tool.

To change the Ethernet configurations:

- 1. On any Web Administration page, click **Configurations**.
- 2. On the secondary menu, click Networking. The following page appears, showing the current settings:
- 3. If a checkmark appears in the box next to DHCP, the dynamic IP address option is enabled. To set a static IP address:
 - a. Click the box to remove the checkmark.
 - b. In the IP address fields, type the static IP address, using your Tab key to move from box to box.
- 4. If no checkmark appears in the box next to DHCP, the static IP address option is enabled. To change a static IP address, in the IP address fields, type in the new address, using your Tab key to move from box to box.
- 5. To change the IP address from a static address to a dynamic address, click the box next to DHCP. The static address is used if DHCP fails to acquire an
- 6. To change the values of the subnet mask, gateway, SNMP server, or the new address, using your Tab key to move from box to box.
- 7. Click **submit.** You must perform a system reset before the new IP address takes effect, or you can use the front panel to power cycle your machine.

Set security options

When you enable the security option, users must enter a password to access the autoloader's functionality. A password enables administrator-level access or operator-level access. For more information on levels of password-protection, see "Passwords" on page 27

How to set Security Option:

- 1. On any Web Administration page, click Configurations.
- 2. On the secondary menu, click **Security**. The following page appears:

To reset the front panel passwords:

- 1. On any Web Administration page, click Configurations.
- 2. On the secondary menu, click **Security**.
- 3. Click the box next to Reset Front Panel Password. A checkmark appears.
- 4. Click submit.

To set a password: When you enter your password on the autoloader's front panel there is no associated username. However, when you click any menu heading on the Web Administration's home page, you are prompted for a username and password. With Web Administration, you can set up to four usernames and IDs, which can include both alpha and numeric characters. Usernames and IDs must be between four and eight characters long.

- 1. On any Web Administration page, click Configurations.
- 2. On the secondary menu, click **Security**.
- 3. From the drop-down list next to Select User Type, select Administrator or Operator.
- 4. In the Username field, enter a username.
- 5. In the Password field, enter the password.
- 6. In the Verify Password field, re-enter the password.
- 7. Click submit.

To set the authorized client list:

- 1. On any Web Administration page, click Configurations.
- 2. On the secondary menu, click **Security.**

Under Client Authorization Control is a list of the IP addresses that are authorized to perform web administration of this unit. There are two sets of IP address boxes. You can individually enable/disable and configure each set.

If enabled, each set can be used to specify either a range of IP addresses or a pair of specific IP addresses that are allowed to administer this unit. A set can also be used to specify a single IP address if the desired IP address is entered into both the "a" and "b" portions of the set. When a set is used to specify a range of IP addresses, the "b" portion of each address set must be greater than or equal to the "a" portion of that address set.

If neither set is enabled, any IP client can administer the unit. If a single set is enabled, only clients that pass the test specified by that set are allowed administration access. If both sets are enabled, any client that passes either of the two filter tests can administer the unit. The web server always allows any client to view the status information of the unit, regardless of the authorized client list or the overlap control policy.

- 3. Use the drop-down box to enable or disable the sets.
- 4. Type the IP addresses in the boxes.
- 5. Click submit.

To set the client overlap control:

- 1. On any Web Administration page, click **Configurations**.
- 2. On the secondary menu, click Security.
- 3. Select a security option from the Client Overlap Control options:
 - No Locking allows multiple users to access the system and issue requests.
 - Full Locking allows only one user to access the system and issue requests.

- Time-based Locking allows only one user to access the system and issue requests with the lock expiring after a designated amount of inactivity (in seconds).
- Home/Logout is used to release a full or time-based lock and permit another user to access the system.

Note: Locking is only available to users on the authorized client list.

4. Click submit.

Diagnostics page

From the Diagnostics page, you can run loader test and drive tests.

How to run a diagnostic test

- 1. On any Web Administration page, click **Diagnostics**.
- 2. From the Test t drop-down menu, select the diagnostic test that you want to
- 3. Specify a loop count if desired.
- 4. Click submit. If you selected a loader test, the test runs. If you selected a drive test, additional options appear. Select the desired options and press submit.
- 5. While the test is running, you can view the status of the test. Under View Diagnostic Test Progress, click View Status.
- 6. To refresh the status information, click **Diagnostics** and then click **Security**.

How to view error or history logs:

To view error or history logs do the following:

- 1. On any Web Administration page, click **Diagnostics**.
- 2. Under View Error and History Logs, select Autoloader or Drive.
- 3. Under View Error and History Logs, click View Logs. You can also save the logs to a file by clicking Save Logs. If you save logs to a file, you must select a destination folder within 60 seconds.

Note: Service personnel might want to use these logs.

Identify autoloader

You can identify the physical location of the autoloader by requesting the LCD backlight to flash for a specified number of seconds.

- 1. Under Identification, enter the number of seconds.
- 2. Click **Identify.** The LCD backlight flashes for the specified number of seconds.


Perform a system reset

You can perform a system reset by clicking System Reset under System Reset. A system resets takes at least three minutes if there is a tape in the drive, or approximately 30 seconds otherwise. You will use system reset when making SCSI ID changes, mode changes, and IP address changes.

Get system updates

You can browse to find system updates and then upload the updates. To get system updates on any Web Administration page, click **Updates**.

- 1. Click Browse.
- 2. Go to http://www.ibm.com/support, search on'Tapetool', and download the appropriate firmware file to a temporary directory on your server.
- 3. Navigate to the location of the system update.



Chapter 4. Using tape cartridges

This chapter explains how to use the tape cartridges and clean the tape drive.

Note: You must use only the following supported data cartridges. Use of unsupported data cartridges may void your warranty or result in billable service calls.



Inspect your tapes (for 360716x only)

A Visual Mechanical Inspection (VMI) allows you to identify any potential tape cartridge problems and prevent accidental loss of data or damage to the DLT tapes or Super DLT tapes that are in your tape drives. Perform a VMI in the following situations:

- Whenever you change or load a new tape cartridge
- If a tape cartridge is dropped or subjected to physical shock
- If the tape drive becomes inoperable after loading a tape cartridge
- If you receive a shipment of tape cartridges that shows any sign of shipping damage




How to perform a VMI (for 360716x only)

To perform a VMI, do the following:

- 1. Remove the tape cartridge from its protective plastic case.
- 2. Check the tape cartridge for obvious cracks or other physical damage. Look for broken or missing parts.
- 3. Gently shake the tape cartridge. Listen for any rattling or sounds of loose pieces inside the cartridge. If you hear anything, do not use the cartridge.
- 4. Hold the tape cartridge so that the end that is inserted into the tape drive is facing you. On the left-hand side of the tape cartridge you should see a small



plastic tab. This is the left reel lock and can break if the cartridge is dropped. If you cannot see the tab, do not use the cartridge.



5. Look at the bottom of the tape cartridge. The bottom reel lock is located in the lower right corner and can break if the cartridge is dropped. If you cannot see the tab, do not use the cartridge.

Note: On normal DLT tape cartridges, the reel lock is white and easy to see. On the SDLT tape cartridge the reel lock is black and more difficult to see.



6. Finally, check for proper operation of the tape cartridge's write-protect switch. This sliding switch, located on the end of the tape cartridge and used for the tape label, snaps back and forth. If the tape cartridge is set to provide write protection, an orange indicator will be visible.

Protecting your tapes

The following tips will help to extend the life of your tapes:

- Remove dust on the outside of tape cartridges with a damp cloth.
- Do not use adhesive labels or POST-IT notes on the top, side, or bottom of your tape cartridge. Use only the label provided with each cartridge and slide it in the label slot on the cartridge.
- Do not use graphite pencils, water-soluble felt pens, or other debris-producing writing instruments on labels.
- Never erase a label always replace it.
- Put unused cartridge labels in a separate location. A static electricity charge on a cartridge might cause a label to cling to the cartridge. If you accidentally insert a label into the drive along with a cartridge, the label might prevent the hub reel and drive gear from meshing.
- Do not touch or allow direct contact with tape or tape leader. Dust or natural skin oils might contaminate the tape and impact tape performance.
- Do not expose the tape cartridge to moisture or direct sunlight.

- Do not expose cartridges to extreme temperatures or humidity. Refer to the documentation that comes with your tape media for appropriate operating and storage temperatures.
- Do not expose tape cartridges to magnetic fields.
- Avoid unnecessary opening of the cartridge door; this can expose the tape to contamination or physical damage.
- Do not drop the tape cartridges or subject the cartridges to physical shock.
- Do not insert any cartridge that has been dropped into a tape drive without a thorough inspection. A dropped cartridge can have dislodged, loosened, or damaged internal components which can also damage the tape drive.
- Do not take tape cartridges apart.
- Do not leave cartridges in the tape drive when the autoloader power is off.

Transporting your tapes

The following tips will help you move your tapes safely from one location to another:

- Always keep each tape cartridge in its protective plastic case when it is not in the tape drive or autoloader magazine.
- When carrying tape cartridges in their cases, always orient the cases so that the grooves in the cases interlock. This prevents the cases from slipping apart and falling.
- Do not carry cartridges loosely in a box or in any other container. Allowing cartridges to hit together exposes them to unnecessary physical shock.

Storing your tapes

The following tips will help you protect your tapes and the data that they contain when you store them:

- Never stack the tape cartridges in a stack of more than five.
- When placing tape cartridges in archival storage, make sure you stand each tape cartridge vertically.
- Store tape cartridges in their plastic containers and in the environmental conditions recommended in your tape media documentation.
- If storage and/or transportation of a tape cartridge has exposed the tape cartridge to conditions outside the recommended environment, "condition" by letting the tape set in its new environment for a 24-hour period.
- Do not place cartridges on or near devices that might produce magnetic fields such as computer monitors, motors, or video equipment. Such exposure can alter or erase data on the tape.

The Write-Protect Switch

All tape cartridges have a write-protect switch to prevent accidental erasure of data. When you enable write-protection, existing data on the tape cannot be overwritten, nor can additional data be appended to the tape. When you disable write-protection, existing data on the tape can be overwritten, and additional data can be appended.

Note: Before loading a cartridge into your autoloader, make sure that you set the write-protect switch to the desired position.




Cleaning the tape drive

Your tape drive's read/write head might need to be cleaned periodically. When cleaning is needed, the drive automatically requests the backup software to perform a cleaning operation. However, you can also initiate cleaning from the front panel as needed.

To clean your tape drive, you need to use a cleaning tape (included in your option package for your convenience). You can order additional cleaning or data cartridges by following the directions on the cartridge insert. The DLT tape cleaning tape looks just like a DLT tape IV cartridge, except that it has a beige shell. The Super DLT tape cleaning tape looks just like a Super DLT tape I cartridge, except that its shell is also beige.

Note: You must use only the following supported cleaning cartridges. Use of unsupported cleaning cartridges may void your warranty or result in billable service charges.

Insert the Cleaning Tape

You can insert the cleaning tape by one of the following methods:

- Load the cleaning tape directly into an ejected magazine and then reload the magazine. You can then configure your application software to remember where that cleaning cartridge is located, and use it at appropriate intervals.
- Insert the cleaning tape through the mailslot.

To insert the cleaning tape through the mailslot:

- 1. On the main menu, scroll to Command.
- 2. Press Enter.
- 3. On the Command submenu, scroll to Cleaning Tape.
- 4. Press Enter.
- 5. On the Cleaning Tape submenu, scroll to Enter Cleaning Tape.
- 6. Press Enter.

A countdown appears on the LCD. You have 20 seconds to insert the cleaning tape through the mailslot before it re-locks. Push the cartridge in until you meet resistance. If you do not push the cartridge in far enough, the autoloader rejects the tape.

- 7. After you have inserted the cartridge, the prompt Enter to Continue displays. You have five seconds to respond.
- 8. Press Enter.

Note: If the insert cartridge function fails, the cartridge ejects and you will have to perform steps five through seven again.

9. After you insert the cleaning tape through the mailslot, proceed directly to manual cleaning or store the cleaning tape in a magazine slot to be used later.

Storing the cleaning tape

Always store your cleaning tape. When you store the cleaning tape, you can use it in the following ways:

- You can use it later for manual cleaning.
- If the Auto Clean function is enabled, the autoloader can move the cleaning tape from the magazine slot to the tape drive and, after the cleaning cycle, return it to
- If backup software's cleaning function is enabled, the software can move the cleaning tape from the magazine slot to the tape drive and, after the cleaning cycle, return it to its slot (for more information, see your backup software's documentation).

To store the cleaning tape:

- 1. After you have inserted the tape through the mailslot, on the main menu, scroll to Configuration.
- 2. Press Enter. The Configuration submenu appears.
- 3. On the submenu, scroll to Cleaning Tape Location.
- 4. Press Enter. A map of all the magazine slots appears.

Whenever a map of the magazine slots appears on the display, an asterisk (*) indicates a slot occupied by a data cartridge, and an exclamation point (!) indicates a slot occupied by a cleaning cartridge.occupied by a cleaning tape is indicated with an exclamation point (!).

5. Scroll to the slot where you want to store the cleaning tape.

Note: If you store the cleaning tape, you must specify in which slot the tape is to be stored.

6. Press Enter. The autoloader moves the tape to its new location.

Ejecting the cleaning tape

You need to eject the cleaning tape from the autoloader under the following conditions:

- If you do not want to store the cleaning tape in a magazine slot after manually cleaning the tape drive.
- · If the cleaning tape has expired

A cleaning tape cartridge can be used for 20 cleanings. When the tape has been used up, Cleaning Tape Expired displays on the front panel LCD. If you store your cleaning tape, store a new tape after you eject the expired one.

To eject a cleaning tape:

- 1. On the main menu, scroll to Command.
- 2. Press Enter.
- 3. On the Command submenu, scroll to Cleaning Tape.
- 4. Press Enter.
- 5. On the Cleaning Tape submenu, scroll to Eject Cleaning Tape.
- 6. Press Enter. The autoloader ejects the cleaning tape from the mailslot.

Tape drive cleaning methods

You can clean your tape drive in three ways:

- · Manual Cleaning
- Software

Manual Cleaning

If neither Auto Clean nor the backup software's cleaning option are enabled, and the drive requires cleaning, the autoloader displays a cleaning message on the LCD.

Attention: Because the cleaning cartridge is abrasive, you should not use it unless the cleaning message appears.

To clean the tape drive manually:

- 1. On the main menu, scroll to Command.
- 2. Press Enter.
- 3. On the Command submenu, scroll to Cleaning Tape.
- 4. Press Enter.
- 5. On the Cleaning Tape submenu, scroll to Load to Drive.
- 6. Press Enter.

The autoloader moves the cleaning tape from its slot to the tape drive and then cleans the drive with it. When the cleaning is finished, you must return the cleaning tape to its magazine slot.

- 7. On the main menu, scroll to Command.
- 8. Press Enter.
- 9. On the Command submenu, scroll to Cleaning Tape.
- 10. Press Enter.
- 11. On the Cleaning Tape submenu, scroll to Unload from Drive.
- 12. Press Enter. The autoloader removes the cleaning tape from the tape drive.
- **13**. When you have finished manually cleaning the tape drive, do one of the following:
 - Store it to its magazine slot.
 - Eject the cleaning tape from the autoloader.

Software

Set the cleaning option in your software application (if available) so that the software monitors drive cleaning. If your application software supports automatic cleaning, store a cleaning cartridge in the slot specified by the application.

Appendix A. Troubleshooting

Errors that you may experience with your autoloader can range from severe hardware damage to simple connection problems. Before you send the autoloader back to IBM or your service provider, you may be able to fix the problem yourself by following some basic troubleshooting procedures.

This chapter describes how to troubleshoot common errors. It also describes how to contact IBM support and how to return the Customer Replaceable Unit (CRU) that is failing for exchange or repair if necessary.

There is no routine maintenance of the autoloader.

Before contacting support

Before you contact IBM support or your service provider, be sure that you try all appropriate recommended procedures. The front panel provides some troubleshooting capabilities but is limited. Web Administration provides more detailed information about the autoloader's present state and past performance and is more helpful for troubleshooting errors.

Table 8. Suggested Actions for Performance Problems

Problem

Front Panel and light indicators do not turn on.

Suggested Action

- 1. Verify that the autoloader is plugged in.
- 2. Verify that the power switch on the back is turned on.
- 3. Verify that the DCA is locked into the autoloader Chassis with the 4 screws supplied.
- 4. Contact your Service Provider, or refer to the Service Manual.

Front Panel does not display information but light indicators above the Front Panel are turned on.

- 1. Connect to the autoloader, using Web Administration with the Ethernet and issue a reset from the diagnostic page.
- 2. Verify that the DCA is locked into the autoloader Chassis with the four screws supplied.
- 3. On the Front Panel, press and hold the power switch for 15 seconds, then turn the rear power switch off. Wait 60 seconds and turn the rear power switch back on.
- 4. Contact your service provider, or refer to the Service Manual.

Table 9. Suggested Actions for Performance Problems (continued)

Problem

The autoloader will not communicate with the host system via the SCSI bus.

Suggested Action

- 1. Verify that the SCSI cables are connected to the rear of the autoloader and that the correct LVD Host controller card is installed.
- 2. Verify that the SCSI cables are not damaged or crimped and the total SCSI cable length is not exceeding the maximum required length.

- 5. Issue a System Reset either by using the Web Administration Diagnostic System Reset or by turning off power from the front panel. 6. Contact your Service Provider, or refer to the Service Manual.

The autoloader will not communicate with the host system via the Ethernet.

- 1. Verify that the Ethernet cable is connected to the correct hub.
- 2. Verify the Ethernet configuration settings via the Front Panel. If the DHCP server is available, Ethernet status should indicate DHCP. Otherwise you must set a unique IP address and mask.
- 3. Power off the autoloader by turning off the system from the front panel and turning it back on.
- 4. Contact your service provider, or refer to the Service Manual.
- 1. Use the Web Administration page and verify that the media is in the expected location internal to the autoloader.

The application software reports a failure locating a piece of media, or the application software fails to move a piece of media as requested.

- 2. Using the Web Administration diagnostic tool, execute the Health Check command.
- 3. Issue a System Reset either by using the Web Administration Diagnostic System Reset or by turning off power from the front panel.
- 4. Contact your Service Provider, or refer to the Service Manual.

The application software reports an error while reading or writing a piece of media.

- 1. Make sure you are using supported media.
- 2. From the Web Administration Diagnostic page, execute the Write/Read Tape drive test.
- 3. Issue a System Reset either by using the Web Administration Diagnostic System Reset or by turning off power from the front panel.
- 4. Contact your Service Provider, or refer to the Service Manual.
- 1. Issue a System Reset either by using the Web Administration Diagnostic System Reset or by turning off power from the front panel.
- 2. Contact your Service Provider, or refer to the Service Manual.

Other failures occur.

Appendix C. Upgrading and replacing CRUs

This appendix describes how to upgrade and replace Customer Replaceable Units (CRUs).

These following components are defined as CRUs and are replaceable in the field by the customer or by a field technician:

- Drive carrier assembly (DCA)
- · Barcode reader
- Cartridge magazine
- · Slide rail kit

Attention

CRUs for DLT/SDLT and LTO are not interchangeable.

Replacing a DCA

Note: Do not apply power to the DCA unless the DCA is fully installed (all four screws installed) to the autoloader.

Before you can replace a DCA, you need to remove the currently installed unit. Then you can install your new DCA. If you replace or upgrade your autoloader's DCA, you do not need to reconfigure the settings for the DCA or for the SCSI bus.

You will need a #2 Phillips screwdriver to replace a DCA:

Remove a DCA

Before you replace your autoloader's DCA, you must turn off power to the autoloader and disconnect the power and SCSI cables from the back of the DCA. You must also make sure the tape drive does not contain a cartridge.

To unload a tape from the tape drive, see "Using data cartridges" on page 33.


Note: This device is static sensitive. Proper grounding and handling precautions are required before removing the DCA from the package. Suggested grounding: 1) Use an ESD wrist strap that is connected to the autoloader. 2) Touch the antistatic plastic package that came with the DCA to a metal part of the autoloader chassis while removing the DCA from the package.

To remove the DCA:


- 1. Turn off the DCA power.
- 2. Disconnect all cords and cables from the back of the DCA.





To install a DCA:


1. Grasp the DCA by the handle with one hand and support it underneath with the other hand.

- 12. Put the autoloader back into the rack or cabinet in which it was mounted.
- 13. Replace the magazine or magazine blank in the right magazine bay.
- 14. Power on the autoloader. The autoloader automatically detects the presence of the barcode reader.

Execute diagnostics:

The IBM service specialist will assist with determining if your equipment is functioning as specified. It may be necessary to isolate the failing xSeries/Netfinity and/or IBM component from any active production environment in order to execute diagnostics and perform defect isolation routines. It is the responsibility of the customer to make the IBM system and/or IBM components available for the execution of diagnostics and the defect isolation routines.

Check software:

The IBM service specialist will assist you to ensure that the proper BIOS, firmware, device drivers and other supporting IBM software have been installed and configured correctly. This may require gathering information about the relevant software levels manually or having to run IBM approved utilities to capture this information. If necessary, your server may need to be in an isolated environment. It is the responsibility of the customer, with the assistance of the service specialist, to perform this activity, as the IBM Statement of Limited Warranty does not include on-site assistance with this information gathering activity.

Warranty service and support

With the original purchase of an IBM server, you have access to extensive service and support. During the IBM Machine warranty period, you may call IBM or your reseller for problem-determination assistance under the terms of the IBM Statement of Limited Warranty.

The following services are available during the warranty period:

Problem determination - Trained personnel are available to assist you with determining if you have a hardware problem and deciding what action is necessary to fix the problem.

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines:IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

Extent of Warranty: The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

Items Not Covered by Warranty

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided WITHOUT WARRANTIES OF ANY KIND.

Warranty Service

To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

Governing Law

Governing Law: The following replaces "laws of the country in which you acquired the *Machine" in the first sentence:* laws of the State of New York.

ASIA PACIFIC

AUSTRALIA

The IBM Warranty for Machines: *The following paragraph is added to this Section:* The warranties specified in this Section are in addition to any rights you may have under the Trade Practices Act 1974 or other similar legislation and are only limited to the extent permitted by the applicable legislation.

Limitation of Liability: The following is added to this Section: Where IBM is in breach of a condition or warranty implied by the Trade Practices Act 1974 or other similar legislation, IBM's liability is limited to the repair or replacement of the goods or the supply of equivalent goods. Any disputes arising from or in connection with this Agreement will first be resolved by friendly negotiations, failing which either of us has the right to submit the dispute to the China International Economic and Trade Arbitration Commission in Beijing, the PRC, for arbitration in accordance with its arbitration rules in force at the time. The arbitration tribunal will consist of three arbitrators. The language to be used therein will be English and Chinese. An arbitral award will be final and binding on all the parties, and will be enforceable under the Convention on the Recognition and Enforcement of Foreign Arbitral Awards (1958).

The arbitration fee will be borne by the losing party unless otherwise determined by the arbitral award.

During the course of arbitration, this Agreement will continue to be performed except for the part which the parties are disputing and which is undergoing arbitration.

EUROPE, MIDDLE EAST, AFRICA (EMEA)

If you purchase an IBM Machine in a Middle Eastern or African country, you may obtain warranty service for that Machine from the IBM entity within the country of purchase, if that IBM entity provides warranty service in that country, or from an IBM reseller, approved by IBM to perform warranty service on that Machine in that country. Warranty service in Africa is available within 50 kilometers of an IBM authorized service provider. You are responsible for transportation costs for Machines located outside 50 kilometers of an IBM authorized service provider.

The applicable laws that govern, interpret and enforce rights, duties, and obligations of each of us arising from, or relating in any manner to, the subject matter of this Statement, without regard to conflict of laws principles, as well as Country-unique terms and competent court for this Statement are those of the country in which the warranty service is being provided, except that in 1) Albania, Bosnia-Herzegovina, Bulgaria, Croatia, Hungary, Former Yugoslav Republic of Macedonia, Romania, Slovakia, Slovenia, Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Turkmenistan, Ukraine, and Uzbekistan, the laws of Austria apply; 2) Estonia, Latvia, and Lithuania, the laws of Finland apply; 3) Algeria, Benin, Burkina Faso, Cameroon, Cape Verde, Central African Republic, Chad, Congo, Djibouti, Democratic Republic of Congo, Equatorial Guinea, France, Gabon, Gambia, Guinea, Guinea-Bissau, Ivory Coast, Lebanon, Mali, Mauritania, Morocco, Niger, Senegal, Togo, and Tunisia, this Agreement will be construed and the legal relations between the parties will be determined in accordance with the French laws and all disputes arising out of this Agreement or related to its violation or execution, including summary proceedings, will be settled exclusively by the Commercial Court of Paris; 4) Angola, Bahrain, Botswana, Burundi, Egypt, Eritrea, Ethiopia, Ghana, Jordan, Kenya, Kuwait,

Liberia, Malawi, Malta, Mozambique, Nigeria, Oman, Pakistan, Qatar, Rwanda, Sao Tome, Saudi Arabia, Sierra Leone, Somalia, Tanzania, Uganda, United Arab Emirates, United Kingdom, West Bank/Gaza, Yemen, Zambia, and Zimbabwe, this Agreement will be governed by English Law and disputes relating to it will be submitted to the exclusive jurisdiction of the English courts; and 5) in Greece, Israel, Italy, Portugal, and Spain any legal claim arising out of this Statement will be brought before, and finally settled by, the competent court of Athens, Tel Aviv, Milan, Lisbon, and Madrid, respectively.

ITALY

Limitation of Liability: *The following replaces the second sentence in the first paragraph:* In each such instance unless otherwise provided by mandatory law, IBM is liable for no more than: 1. (unchanged) 2. as to any other actual damage arising in all situations involving nonperformance by IBM pursuant to, or in any way related to the subject matter of this Statement of Warranty, IBM's liability, will be limited to the total amount you paid for the Machine that is the subject of the claim. Applicability of suppliers and resellers (unchanged).

The following replaces the third paragraph of this Section:
