Hardware Requirements

This Monitor requires a computer with a suitable on-board sub-system or Video Adapter card that can support SXGA 1024 x 768 at 75 Hz.

Make sure the PC's video mode is set in the range of the supported screen addressability shown in the table on page 21.

Workplace Preparation

i This section gives advice on what you should consider before you set up your monitor.

Positioning the Monitor

Choose a suitable place to position the monitor where it is not near fluorescent desk lighting. Ensure that the furniture or equipment can support the weight of the monitor. Allow at least 2 inches (50mm) ventilation space around the monitor.

Height

The monitor should be positioned so that the top of the screen is slightly below your eye level when you sit at your workstation.

Orientation

Choose a position that gives the least reflection from lights and windows, usually at a right angle to any windows. The monitor should be positioned directly in front of you so that you do not have to twist your body to use it. Tilt the monitor to a comfortable viewing angle.

Lifting the Monitor

Do not support the monitor within the screen area. The Liquid Crystal Display is glass and can be damaged by rough handling or excessive pressure. Hold the bottom of the screen with both hands in the positions shown.



Working Practices

Rest

Take regular breaks. Vary your posture, stand up and stretch occasionally as prolonged use of computer workstations can be tiring.

i This section gives advice on how you can work comfortably and reduce fatigue.

Back

You should sit back in your chair and use the backrest.

Hands

Use a light touch on the keyboard, keeping your hands and fingers relaxed. Allow a space in front of the keyboard to rest your wrists when not typing. Consider using a wristpad.

Eyesight

Working with monitors, in common with any prolonged close work, can be visually demanding. Look away from the screen periodically and have your eyesight checked regularly.


Screen settings

Set the screen brightness and contrast to a comfortable level. You may have to adjust this as the lighting changes during the day. Many application programs let you select color combinations which can help you to view in comfort

Connecting your Monitor


Be sure to read the **'Safety Information'** at the front of this User Guide before carrying out this procedure.

- 1. Turn off your PC and all attached devices.
- 2. With the monitor standing vertically, remove the cable covers at the back:
 - remove cable cover 1 by hooking your finger at A and sliding the cover off smoothly.
 - remove cable cover 2 by pressing both sides of the cover and pulling out.




 Place the screen towards the edge of a flat surface with the stand hanging slightly off the edge. Connect the monitor cable and tighten the screws.

4.Next connect the AC adapter.




5. Thread the cables through the metal fitting - the AC adapter cable through A and the monitor cable through B as shown below.




6. You can release the cables from each of the three notches by removing the chips as shown above.

- 7. Turn the monitor upright and refit the covers. Slide on cover 2, fit cover 1 either side of the hinges and slide on.
- 8. Connect the monitor cable to the PC and tighten the screws.
- 9. Connect the power cord to the AC adapter, placing the AC adapter in a safe place.
- 10. Connect the other end of the power cord to a correctly grounded AC power source.



Connecting the keyboard and mouse to the monitor

You do not need to connect the optional keyboard / mouse cable if you use the DPMS function for standby mode. To use the standby mode or extend the cable between the keyboard and mouse. Connect optional keyboard / mouse (P/N: 82H8627) to the connector at the rear of the monitor as shown, then connect the other end of the keyboard and mouse connectors to the PC.



Switching on the Monitor

Switch on the power source and PC. To turn on the monitor, push and release the power switch. To switch it off, push and release the power switch again.

Adjusting the Monitor Position

Viewing Angle

You can tilt the screen backward or rotate the monitor to the left or right, as shown below.



Caring for your Monitor

Be sure to turn off the power before you perform any maintenance on the monitor. Clean your monitor as follows:

- Gently wipe the device covers and the screen with a soft cloth.
- Do not use chemicals such as thinner or benzene. They may damage the surface coating.

Configuring your Monitor

Automatic Setup

The Setup Utility included on the setup option diskettes are for displaying color-bar patterns. They do not replace or modify the display driver.

When you first use your monitor you must perform **Automatic (auto) Setup**. This procedure sets up your monitor to process the video signals from your computer without image discoloration or flicker. After you perform auto setup, the settings are stored and used each time you turn on the monitor.

i The automatic setup instructions require the monitor to be warmed up for 15 minutes. This is not required for normal operation.

Before you begin the auto setup for your PC :

- 1. Make a backup copy of the setup option diskettes supplied with the monitor.
- 2. Make sure the PC's video mode is set in the range in the table of *Supported screen addressability* on page 21.
- 3. Perform the auto setup for each screen mode you use.

- 5. At the command prompt, type 'A:' and press ENTER.
- 6. Type '**TESTPATD**' and press ENTER. The color-bar pattern appears.
- 7. Push the setup switch at the bottom of the monitor. The setup menu appears.
- 8. Push one of the brightness control buttons 🔅 to select AUTO SETUP.
- 9. Push one of the contrast control buttons (+ moves the highlighter up; moves the highlighter down). The AUTO SETUP line changes to start, and auto setup starts.
- 10. Wait until the PRESS [ENTER] KEY message is displayed.
- 11. Press ENTER to continue the auto setup procedure.
- 12. The AUTO SETUP line changes to COMPLETED when auto setup is complete.
- 13. Push the setup switch at the bottom of the monitor. The setup menu disappears.

- 13. Open the OS/2 full-screen window or an OS/2 window.
- 14. At the command prompt type A: and press ENTER.
- 15. Type TESTPATS and press ENTER.

Quick Setup

Check that the screen resolution and the frequencies are within the Supported screen addressability on page 21. If not, change the settings on the computer to set them within the range.


You need a full screen image to perform proper auto setup. You also need a clear contrast between the brightest part of the screen and the darkest for correct adjustment. Otherwise, the screen may flicker.

If the "Save Parameters?" message is not displayed or the auto setup value "START" does not change, push the contrast control button to exit auto setup and go back to step 4. Display another full-screen image and redo auto setup.

If you are using a workstation, the screen appears greenish because the black level is shifted due to the difference of the voltage level of the video signals. If this happens, adjust OFFSET G in the Specialist Controls on page 16.

You can perform a quick setup without running the Auto-Setup application

- 1. Turn on the monitor and the System Unit and wait for about 15 minutes until the machine warms up.
- 2. Start the operating system on the System Unit and display a full-screen image.
- 3. Push the setup switch on the front of the monitor. The setup main menu appears.




- 4. Press one of the brightness control 🔅 buttons to select AUTO SETUP.
- 5. Press one of the contrast control **(**) buttons. After about 10 seconds, the message "Save parameters?" is displayed.
- To save the settings for the monitor, push a contrast control button.
 To discard the settings (because some problem such as a screen flicker occurs), push a brightness control button.
- 7. Press the setup switch on the back of the monitor to turn off the setup main menu.

Troubleshooting

If you suspect something is not working correctly, you should :

- 1. Turn on the computer and monitor.
- 2. Set the brightness $\dot{\mathbf{Q}}$ control to the proper position.
- 3. Ensure that all cables are securely connected.
- 4. Disable standby mode if it is enabled. Push the setup switch on the back of the monitor to determine whether standby mode is enabled.
- 5. Disable the computer's screen saver program if it is enabled.
- Run the auto setup procedure described in *Configuring your Monitor* on page 7
- 7. Adjust the CLOCK parameter in the *Intermediate Controls* on page 15 to suppress the display of vertical stripes.
- 8. To restore all the auto setup settings to the original values in effect when the monitor was shipped, press each minus button of the brightness and the contrast control simultaneously and turn on the monitor. Both LED indicators turn on and off, and all settings are restored.
- 9. Set the screen mode to the *Supported screen addressability* in the table on page 21.
- 10. Perform AUTO SETUP for each display mode (each screen resolution).
- 11. Disable Interlaced Mode. (The monitor does not support interlaced mode).

The LCD contains over 2,300,000 thin-film transistors (TFTs). A small number of missing, discolored, or lighted dots may be present on the screen, which is an intrinsic characteristic of the TFT LCD technology and is not an LCD defect.

Setting Non Interlaced Mode

The monitor does not support interlace mode. If the video settings of your IBM PC specify interlace mode, change them with the following steps:

- 1. Turn on the monitor.
- 2. Turn on your PC.
- 3. Press F1 while the message 'Press F1 for configuration/setup' is being displayed.
- 4. Select Device and I/O in the Device Configuration Utility.
- 5. Select Setup Video.
- 6. Set the display type to Customize and the refresh rate to 60Hz or 75Hz.
- 7. Press ESC three times.
- 8. Select Save and Exit.
- 9. Non Interlaced mode has been set.

Production Status
